# **ETF & Mutual Fund Rankings: Materials Sector**

The Materials sector ranks seventh out of the ten sectors as detailed in our <u>2Q17 Sector Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Materials sector ranked eighth. It gets our Dangerous rating, which is based on an aggregation of ratings of 10 ETFs and 11 mutual funds in the Materials sector as of April 10, 2017. See a recap of our <u>1Q17 Sector Ratings here</u>.

Figure 1 ranks from best to worst all ten Materials ETFs and Figure 2 shows the five best and worst rated Materials mutual funds. Not all Materials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 125). This variation creates drastically different investment implications and, therefore, ratings.

Investors should not buy any Materials ETFs or mutual funds because none get an Attractive-or-better rating. If you must have exposure to this sector, you should buy a basket of Attractive-or-better rated stocks and avoid paying undeserved fund fees. Active management has a long history of not paying off.

Our <u>robo-analyst technology</u> empowers our unique <u>ETF and mutual fund rating methodology</u>, which leverages our rigorous analysis of each fund's holdings. We think advisors and investors focused on prudent investment decisions should include analysis of fund holdings in their research process for ETFs and mutual funds.

Fidelity MSCI Materials Index ETF (FMAT) is the top-rated Materials ETF and Vanguard Materials Index Fund (VMIAX) is the top-rated Materials mutual fund. Both earn a Neutral rating.

VanEck Vectors Steel ETF (SLX) is the worst rated Materials ETF and Rydex Basic Materials Fund (RYBMX) is the worst rated Materials mutual fund. Both earn a Very Dangerous rating.

160 stocks of the 3000+ we cover are classified as Materials stocks.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. #### PERFORMANCE OF HOLDINGS = PERFORMANCE OF FUND





Accounting data is not designed for equity investors, but for debt investors. Accounting data must be translated into economic earnings to understand the profitability and valuation relevant to equity investors. Respected investors (e.g. Adam Smith, Warren Buffett and Ben Graham) have repeatedly emphasized that accounting results should not be used to value stocks. Economic earnings are what matter because they are:

- 1. Based on the complete set of financial information available.
- 2. Standard for all companies.
- 3. A more accurate representation of the true underlying cash flows of the business.
