



ETF & Mutual Fund Rankings: Industrials Sector

The Industrials sector ranks fifth out of the 11 sectors as detailed in our [3Q18 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Industrials sector ranked second. It gets our Neutral rating, which is based on an aggregation of ratings of the 439 stocks in the Industrials sector as of July 17, 2018. See a recap of our [2Q18 Sector Ratings here](#).

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Industrials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 20 to 353). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Industrials sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

ICTRX is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

XHB is the top-rated Industrials ETF and FSLEX is the top-rated Industrials mutual fund. Both earn a Very Attractive rating.

XTN is the worst rated Industrials ETF and PGIAX is the worst Industrials mutual fund. They both earn an Unattractive rating.

439 stocks of the 2850+ we cover are classified as Industrials stocks.

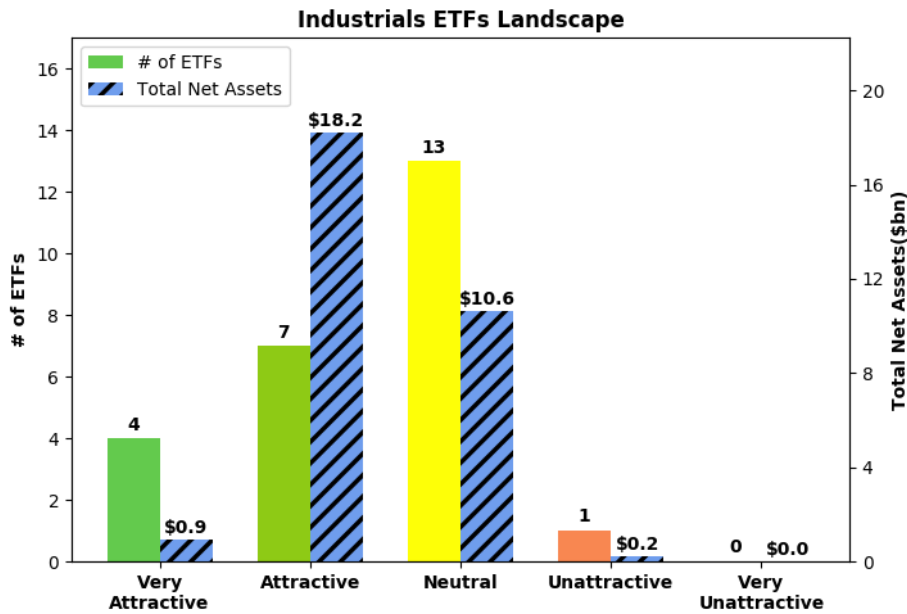

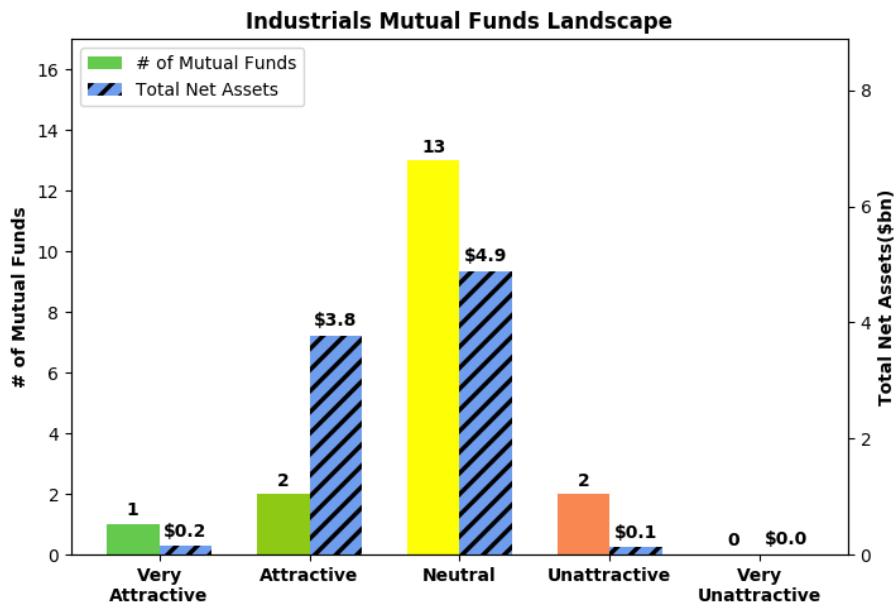
