



# ETF & Mutual Fund Rankings: Telecom Services Sector

The Telecom Services sector ranks second out of the 11 sectors as detailed in our <u>3Q18 Sector Ratings for</u> <u>ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Telecom Services sector ranked ninth. It gets our Attractive rating, which is based on an aggregation of ratings of the 43 stocks in the Telecom Services sector as of July 17, 2018. See a recap of our <u>2Q18 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Telecom Services sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 22 to 81). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Telecom Services sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

WIREX is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

IXP is the top-rated Telecom Services ETF and FWRLX is the top-rated Telecom Services mutual fund. Both earn a Very Attractive rating.

FCOM is the worst rated Telecom Services ETF and FTUAX is the worst Telecom Services mutual fund. They both earn a Very Unattractive rating.

43 stocks of the 2850+ we cover are classified as Telecom Services stocks.


#### PERFORMANCE OF HOLDINGs = PERFORMANCE OF FUND


