



ETF & Mutual Fund Rankings: All Cap Blend Style

The All Cap Blend style ranks third out of the twelve fund styles as detailed in our [4Q18 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Blend style ranked third as well. It gets our Attractive rating, which is based on an aggregation of ratings of 112 ETFs and 797 mutual funds in the All Cap Blend style as of October 22, 2018. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 4 to 7682). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the All Cap Blend style should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

CLIX is the worst rated All Cap Blend ETF and SLVYX is the worst rated All Cap Blend mutual fund. Both earn a Very Unattractive rating.

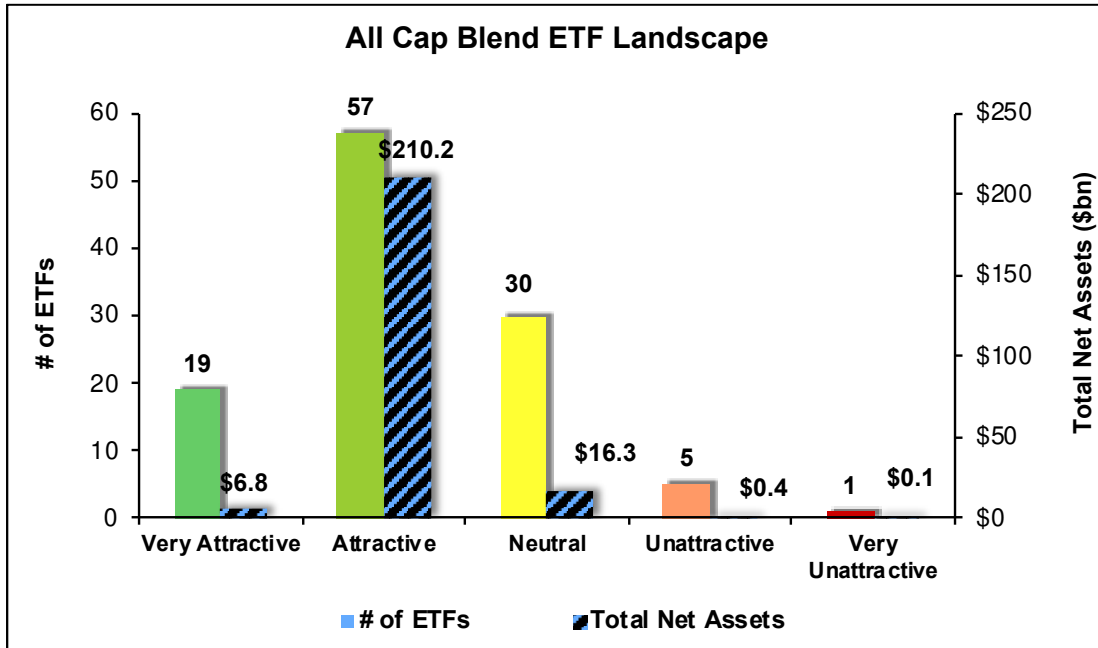

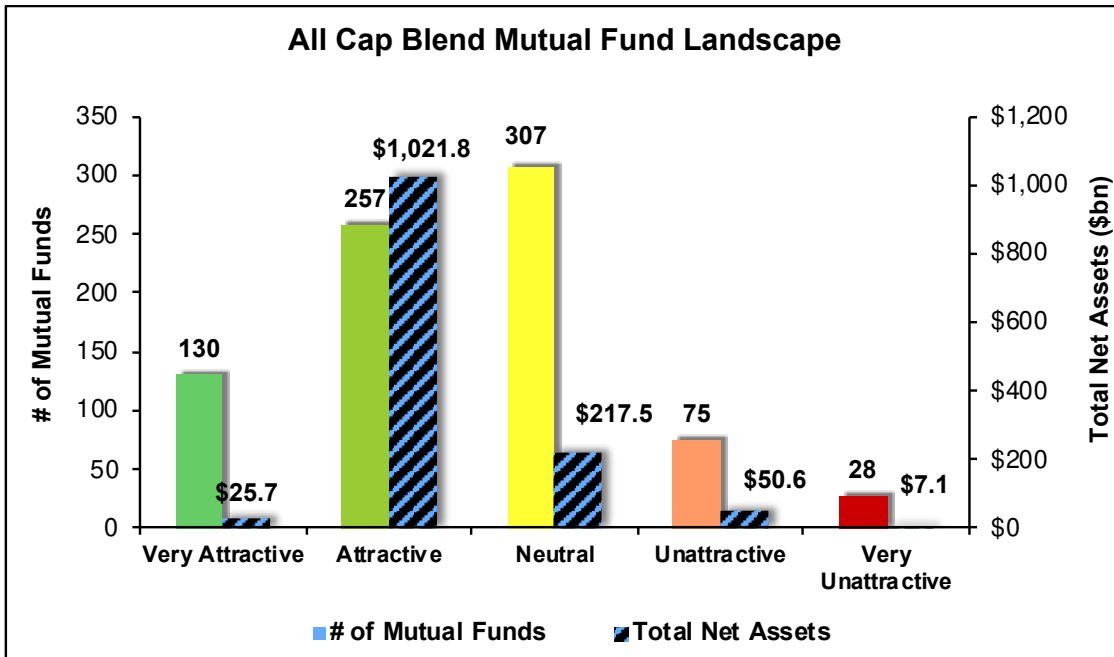
