ETF & Mutual Fund Rankings: Technology Sector

The Technology sector ranks second out of the 11 sectors as detailed in our <u>4Q18 Sector Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Technology sector ranked third. It gets our Attractive rating, which is based on an aggregation of ratings of the 440 stocks in the Technology sector as of October 12, 2018. See a recap of our <u>3Q18 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Technology sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 345). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Technology sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Two mutual funds (BOGSX, ICTEX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

IXN is the top-rated Technology ETF and FDCPX is the top-rated Technology mutual fund. Both earn a Very Attractive rating.

ARKK is the worst rated Technology ETF and RSIFX is the worst Technology mutual fund. They both earn a Very Unattractive rating.

440 stocks of the 2850+ we cover are classified as Technology stocks.




