

# **ETF & Mutual Fund Rankings: Telecom Services Sector**

The Telecom Services sector ranks fifth out of the 11 sectors as detailed in our <u>4Q18 Sector Ratings for ETFs</u> and <u>Mutual Funds</u> report. <u>Last quarter</u>, the Telecom Services sector ranked second. It gets our Neutral rating, which is based on an aggregation of ratings of the 44 stocks in the Telecom Services sector as of October 12, 2018. See a recap of our <u>3Q18 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Telecom Services sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 22 to 79). This variation creates drastically different investment implications and, therefore, ratings.

WIREX is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

XLC is the top-rated Telecom Services ETF and VTCAX is the top-rated Telecom Services mutual fund. Both earn an Attractive rating.

FCOM is the worst rated Telecom Services ETF and FTUAX is the worst Telecom Services mutual fund. They both earn a Very Unattractive rating.

44 stocks of the 2850+ we cover are classified as Telecom Services stocks.

### Figure 3: Separating the Best ETFs From the Worst ETFs





Figure 4: Separating the Best Mutual Funds from the Worst Mutual Funds
