



## ETF & Mutual Fund Rankings: All Cap Blend Style

The All Cap Blend style ranks second out of the twelve fund styles as detailed in our [1Q19 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Blend style ranked third. It gets our Attractive rating, which is based on an aggregation of ratings of 105 ETFs and 778 mutual funds in the All Cap Blend style as of January 22, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 4 to 7690). This variation creates drastically different investment implications and, therefore, ratings.

Seven mutual funds are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

State Street SPDR SSGA Gender Diversity Index (SHE) is the top-rated All Cap Blend ETF and Hennessy Cornerstone Large Growth Fund (HILGX) is the top-rated All Cap Blend mutual fund. Both earn a Very Attractive rating.

[ProShares Long Online/Short Stores ETF \(CLIX\)](#) is the worst rated All Cap Blend ETF and Upright Investments Assets Allocation Plus Fund (UPAAX) is the worst rated All Cap Blend mutual fund. CLIX earns an Unattractive rating and UPAAX earns a Very Unattractive rating.

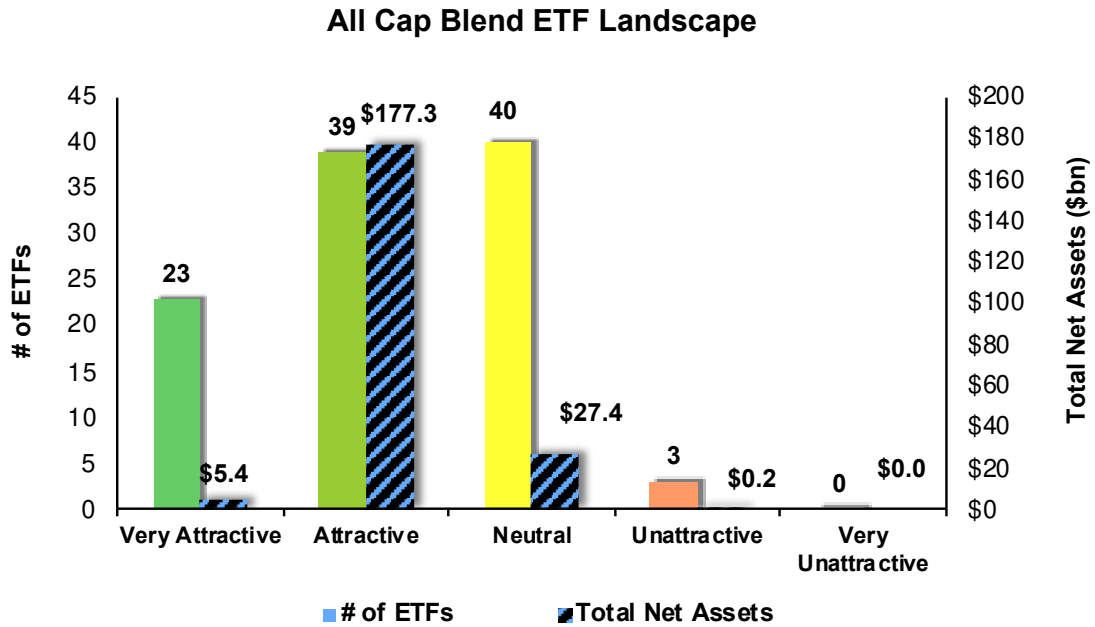

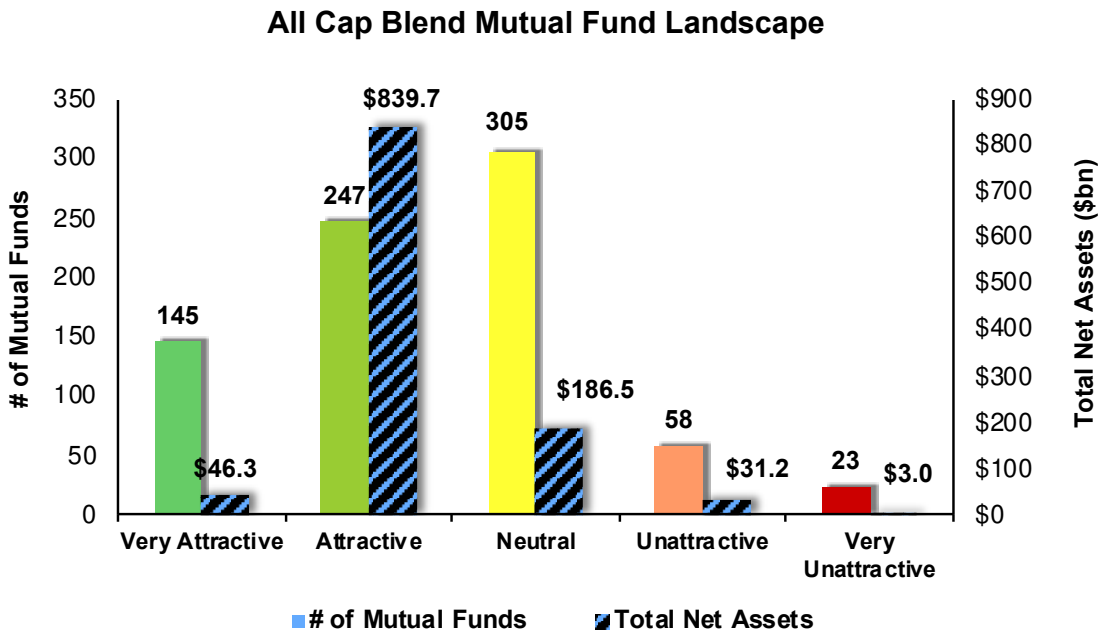
