

ETF & Mutual Fund Rankings: Consumer Non-cyclicals Sector

The Consumer Non-cyclicals sector ranks first out of the 11 sectors as detailed in our <u>1Q19 Sector Ratings for</u> <u>ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Consumer Non-cyclicals sector ranked first. It gets our Very Attractive rating, which is based on an aggregation of ratings of the 132 stocks in the Consumer Non-cyclicals sector as of January 11, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Noncyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 126). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Consumer Non-cyclicals sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

ICLEX is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

FSTA is the top-rated Consumer Non-cyclicals ETF and VCSAX is the top-rated Consumer Non-cyclicals mutual fund. Both earn a Very Attractive rating.

PSCC is the worst rated Consumer Non-cyclicals ETF and FSHOX is the worst Consumer Non-cyclicals mutual fund. They both earn a Neutral rating.

132 stocks of the 2750+ we cover are classified as Consumer Non-cyclicals stocks.




