# **ETF & Mutual Fund Rankings: Energy Sector**

The Energy sector ranks fifth out of the 11 sectors as detailed in our 1Q19 Sector Ratings for ETFs and Mutual Funds report. Last quarter, the Energy sector ranked tenth. It gets our Neutral rating, which is based on an aggregation of ratings of the 171 stocks in the Energy sector as of January 11, 2019. See a recap of our 4Q18 Sector Ratings here.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Energy sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 23 to 290). This variation creates drastically different investment implications and, therefore, ratings.

#### Get the best fundamental research

Investors should not buy any Energy ETFs or mutual funds because none get an Attractive-or-better rating. If you must have exposure to this sector, you should buy a basket of Attractive-or-better rated stocks and avoid paying undeserved fund fees. Active management has a <u>long history</u> of not paying off.

FIW is the top-rated Energy ETF and CGEYX is the top-rated Energy mutual fund. Both earn a Neutral rating.

IEZ is the worst rated Energy ETF and CRZNX is the worst Energy mutual fund. They both earn a Very Unattractive rating.

171 stocks of the 2750+ we cover are classified as Energy stocks.




