ETF & Mutual Fund Rankings: Financials Sector

The Financials sector ranks second out of the 11 sectors as detailed in our 1Q19 Sector Ratings for ETFs and Mutual Funds report. Last quarter, the Financials sector ranked sixth. It gets our Attractive rating, which is based on an aggregation of ratings of the 420 stocks in the Financials sector as of January 11, 2019. See a recap of our 4Q18 Sector Ratings here.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Financials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 24 to 415). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Financials sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Two mutual funds (FSVLX, ICFSX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

IYG is the top-rated Financials ETF and FSRBX is the top-rated Financials mutual fund. Both earn a Very Attractive rating.

PSCF is the worst rated Financials ETF and RYFNX is the worst rated Financials mutual fund. PSCF earns an Unattractive rating and RYFNX earns a Very Unattractive rating.

420 stocks of the 2750+ we cover are classified as Financials stocks.




