



ETF & Mutual Fund Rankings: All Cap Blend Style

The All Cap Blend style ranks third out of the twelve fund styles as detailed in our [2Q19 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Blend style ranked second. It gets our Attractive rating, which is based on an aggregation of ratings of 108 ETFs and 787 mutual funds in the All Cap Blend style as of April 22, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from four to 7687). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the All Cap Blend style should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Four ETFs (AQCIX, AQCYX, AQCPX, BKPIX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

ProShares UltraPro Dow30 (UDOW) is the top-rated All Cap Blend ETF and Hennessy Cornerstone Large Growth Fund (HILGX) is the top-rated All Cap Blend mutual fund. Both earn a Very Attractive rating.

ProShares Ultra Basic Materials (UYM) is the worst rated All Cap Blend ETF and Upright Assets Allocation Plus Fund (UPAAX) is the worst rated All Cap Blend mutual fund. UYM earns an Unattractive rating and UPAAX earns a Very Unattractive rating.

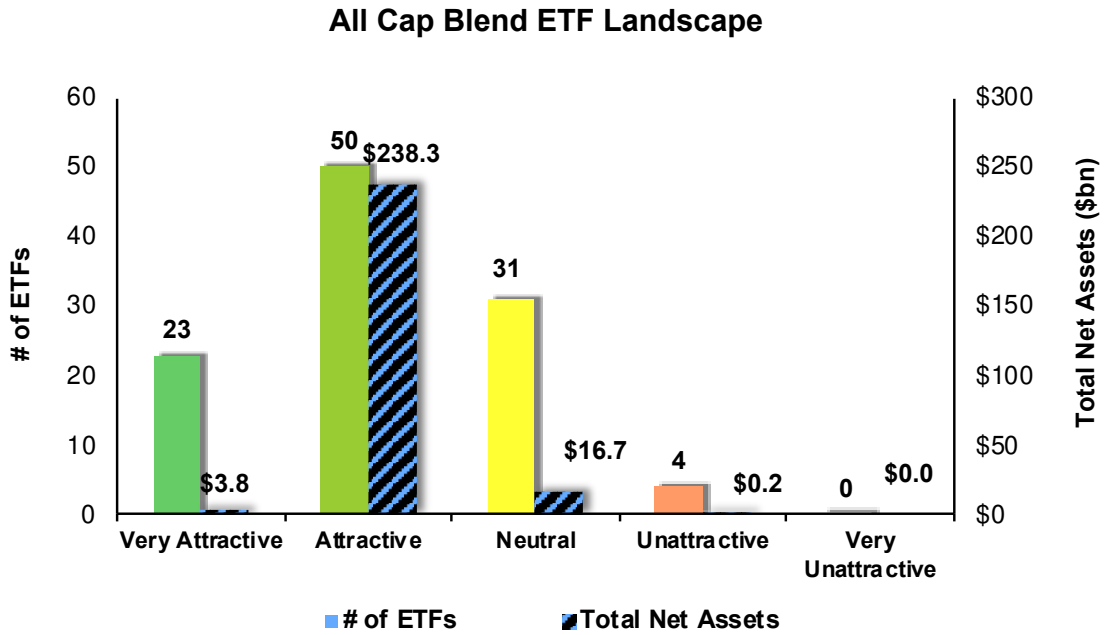

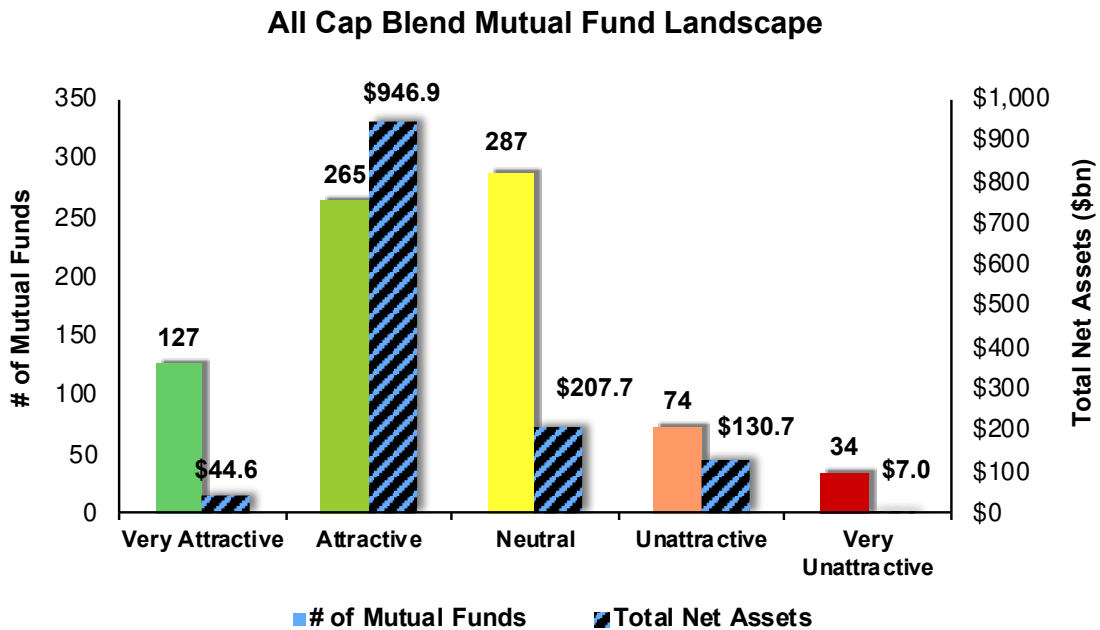
