



ETF & Mutual Fund Rankings: All Cap Value Style

The All Cap Value style ranks fourth out of the twelve fund styles as detailed in our [2Q19 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Value style ranked fourth as well. It gets our Neutral rating, which is based on an aggregation of ratings of 23 ETFs and 382 mutual funds in the All Cap Value style as of April 22, 2019. Figures 1 and 2 show the best and worst rated ETFs and mutual funds in the style. Not all All Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 20 to 1639). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the All Cap Value style should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

American Beacon Alpha Quant Value Fund (AQVVX, AQVYX, AQVPX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

ETF Series Deep Value ETF (DVP) is the top-rated All Cap Value ETF and AIG Focused Dividend Strategy Fund (FDSWX) is the top-rated All Cap Value mutual fund. Both earn a Very Attractive rating.

Legg Mason Low Volatility High Dividend ETF (LVHD) is the worst rated All Cap Value ETF and American Pension Yorktown Capital Income Fund (APIGX) is the worst rated All Cap Value mutual fund. LVHD earns a Neutral rating and APIGX earns a Very Unattractive rating.

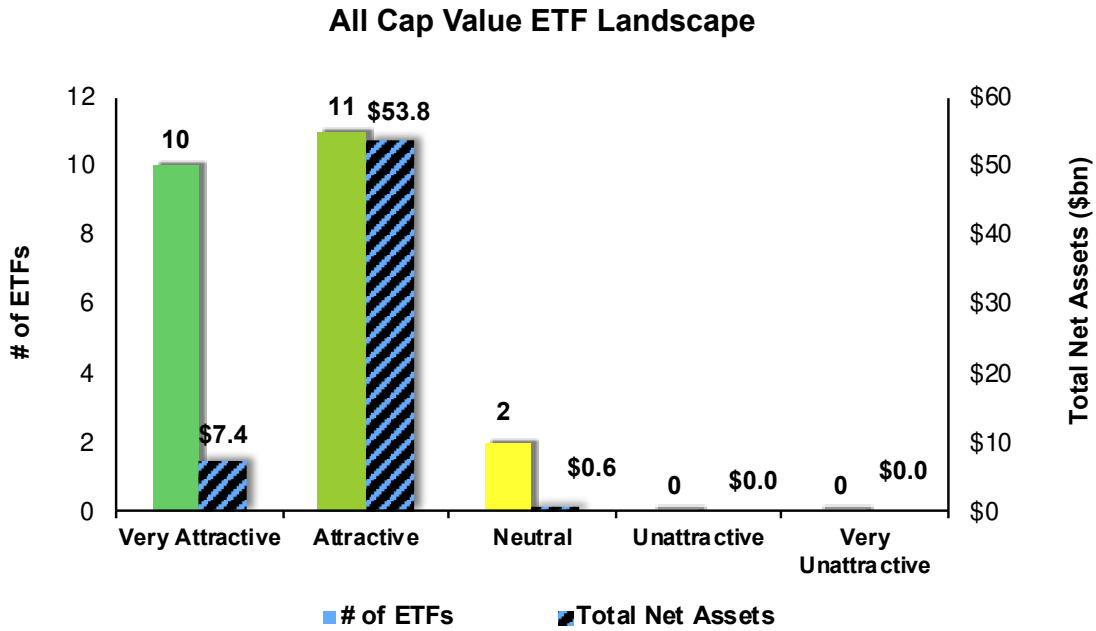

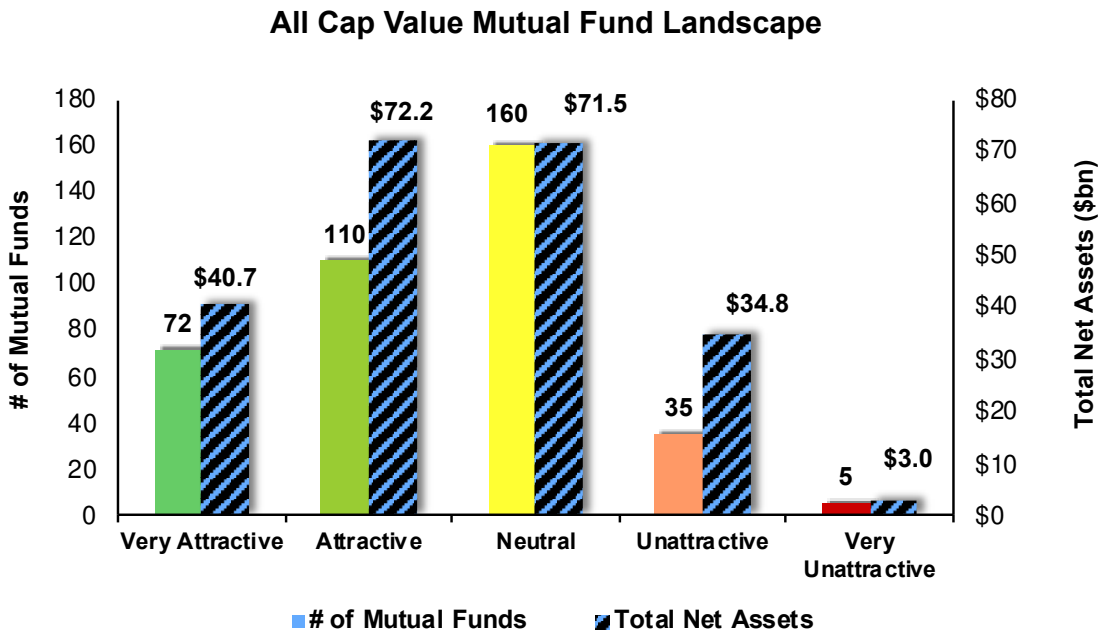
