



ETF & Mutual Fund Rankings: Small Cap Growth Style

The Small Cap Growth style ranks last out of the twelve fund styles as detailed in our [2Q19 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Small Cap Growth style ranked last as well. It gets our Very Unattractive rating, which is based on an aggregation of ratings of 16 ETFs and 375 mutual funds in the Small Cap Growth style as of April 23, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Small Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 27 to 2534). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Small Cap Growth style should buy one of the Attractive-or-better rated mutual funds from Figure 2.

River Oak Discovery Fund (RIVSX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

State Street SPDR S&P 400 Mid Cap Growth ETF (MDYG) is the top-rated Small Cap Growth ETF and Virtus KAR Small Cap Value Fund (VQSRX) is the top-rated Small Cap Growth mutual fund. MDYG earns a Neutral rating and VQSRX earns a Very Attractive rating.

iShares Morningstar Small Cap Growth ETF (JKK) is the worst rated Small Cap Growth ETF and Victory RS Small Cap Growth Fund (RSEGX) is the worst rated Small Cap Growth mutual fund. JKK earns an Unattractive rating and RSEGX earns a Very Unattractive rating.

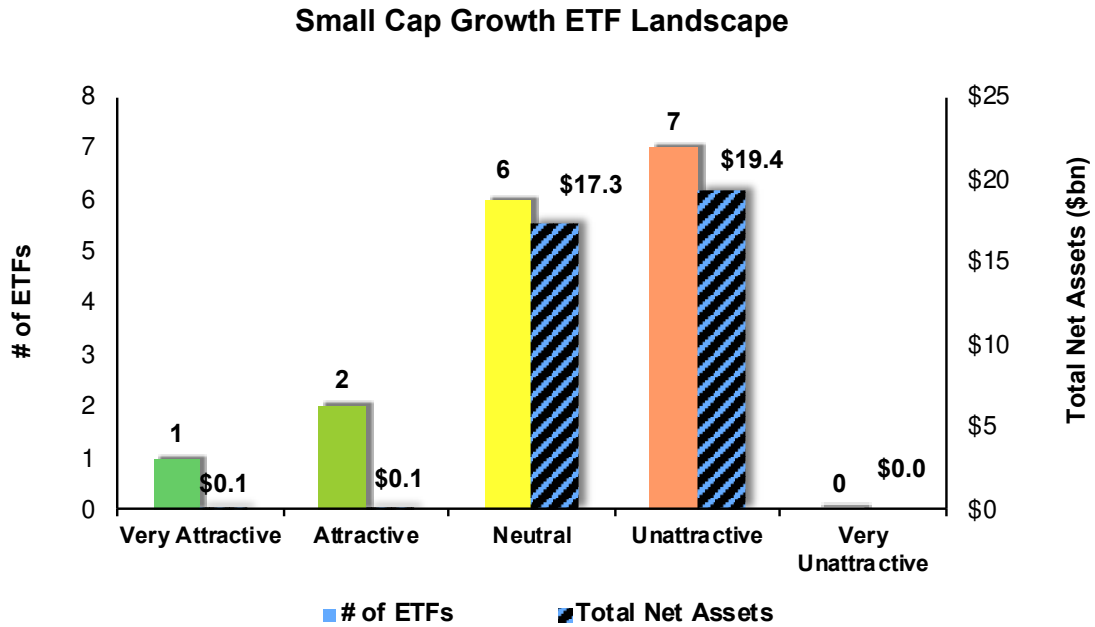

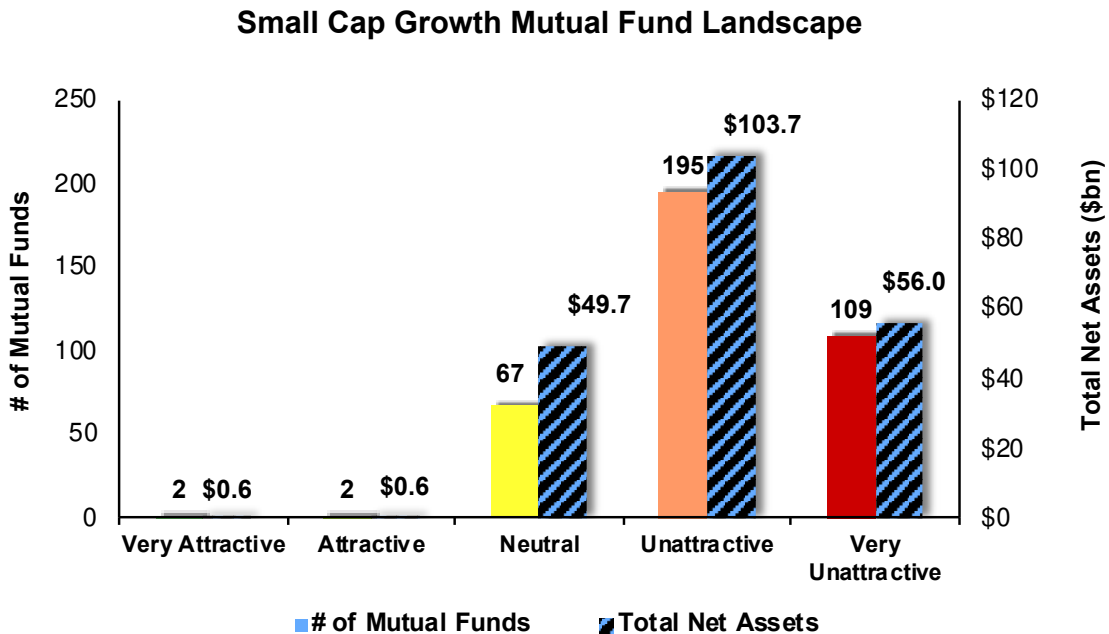
