ETF & Mutual Fund Rankings: Financials Sector

The Financials sector ranks second out of the 11 sectors as detailed in our <u>3Q19 Sector Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Financials sector ranked first. It gets our Attractive rating, which is based on an aggregation of ratings of the 433 stocks in the Financials sector as of July 11, 2019. See a recap of our <u>2Q19 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Financials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 423). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Financials sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Two mutual funds (RYKIX, ICFSX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

KBWB is the top-rated Financials ETF and FSRBX is the top-rated Financials mutual fund. Both earn a Very Attractive rating.

KBWD is the worst rated Financials ETF and RYFNX is the worst rated Financials mutual fund. KBWD earns an Unattractive rating and RYFNX earns a Very Unattractive rating.

433 stocks of the 2800+ we cover are classified as Financials stocks.

Buying a fund without analyzing its holdings is like buying a stock without analyzing its business and finances. Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 


