# **ETF & Mutual Fund Rankings: Healthcare Sector**

The Healthcare sector ranks fourth out of the 11 sectors as detailed in our <u>3Q19 Sector Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Healthcare sector ranked fifth. It gets our Neutral rating, which is based on an aggregation of ratings of the 322 stocks in the Healthcare sector as of July 11, 2019. See a recap of our <u>2Q19 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Healthcare sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 393). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Healthcare sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Four mutual funds (MEDRX, KRXCX, LOGSX, SBHIX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

XPH is the top-rated Healthcare ETF and SWHFX is the top-rated Healthcare mutual fund. XPH earns a Very Attractive rating and SWHFX earns an Attractive rating.

BBP is the worst rated Healthcare ETF and PHLAX is the worst Healthcare mutual fund. They both earn a Very Unattractive rating.

322 stocks of the 2800+ we cover are classified as Healthcare stocks.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 


