



## ETF & Mutual Fund Rankings: Telecom Services Sector

The Telecom Services sector ranks first out of the 11 sectors as detailed in our [3Q19 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Telecom Services sector ranked third. It gets our Very Attractive rating, which is based on an aggregation of ratings of the 40 stocks in the Telecom Services sector as of July 11, 2019. See a recap of our [2Q19 Sector Ratings here](#).

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Telecom Services sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 115). This variation creates drastically different investment implications and, therefore, ratings.

Three mutual funds (FLICX, WIREX, FTICX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

IYZ is the top-rated Telecom Services ETF and FWRLX is the top-rated Telecom Services mutual fund. IYZ earns a Very Attractive rating and FWRLX earns an Attractive rating.

XTL is the worst rated Telecom Services ETF and RYTLX is the worst rated Telecom Services mutual fund. XTL earns an Unattractive rating and RYTLX earns a Very Unattractive rating.

40 stocks of the 2800+ we cover are classified as Telecom Services stocks.

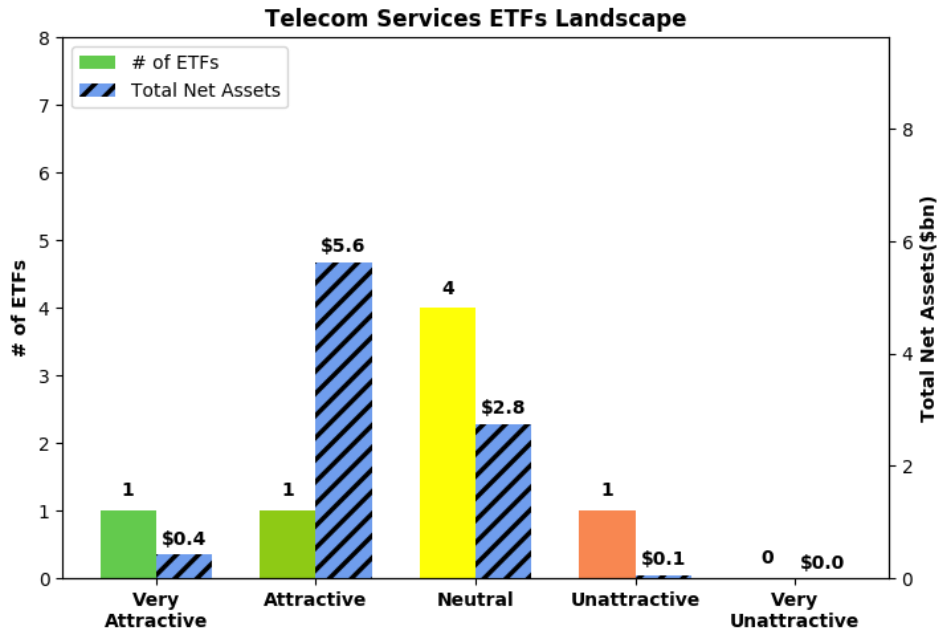

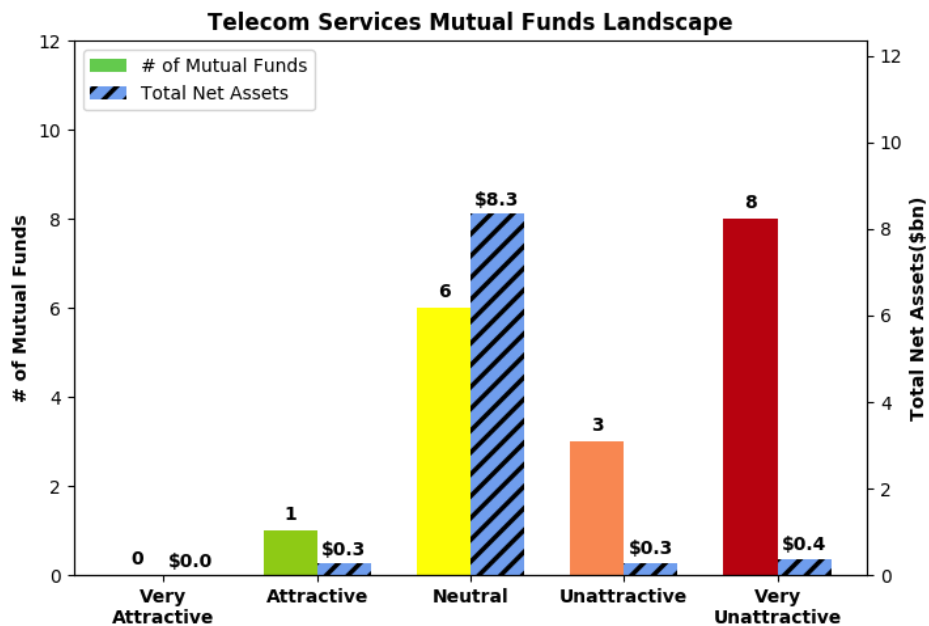
