



## ETF & Mutual Fund Rankings: Small Cap Growth Style

The Small Cap Growth style ranks last out of the twelve fund styles as detailed in our [4Q19 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Small Cap Growth style ranked eleventh. It gets our Very Unattractive rating, which is based on an aggregation of ratings of 20 ETFs and 554 mutual funds in the Small Cap Growth style as of October 18, 2019. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Small Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 27 to 3257). This variation creates drastically different investment implications and, therefore, ratings.

Get the best fundamental research

Investors should not buy any Small Cap Growth ETFs or mutual funds because none get an Attractive-or-better rating. If you must have exposure to this style, you should buy a basket of Attractive-or-better rated stocks and avoid paying undeserved fund fees. Active management has a [long history](#) of not paying off.

State Street SPDR S&P 400 Mid Growth ETF (MDYG) is the top-rated Small Cap Growth ETF and DFA Investment U.S. Small Cap Growth Portfolio (DSCGX) is the top-rated Small Cap Growth mutual fund. Both earn a Neutral rating.

Renaissance Capital IPO ETF (IPO) is the worst rated Small Cap Growth ETF and Dunham Small Cap Growth Fund (DADGX) is the worst rated Small Cap Growth mutual fund. Both earn a Very Unattractive rating.

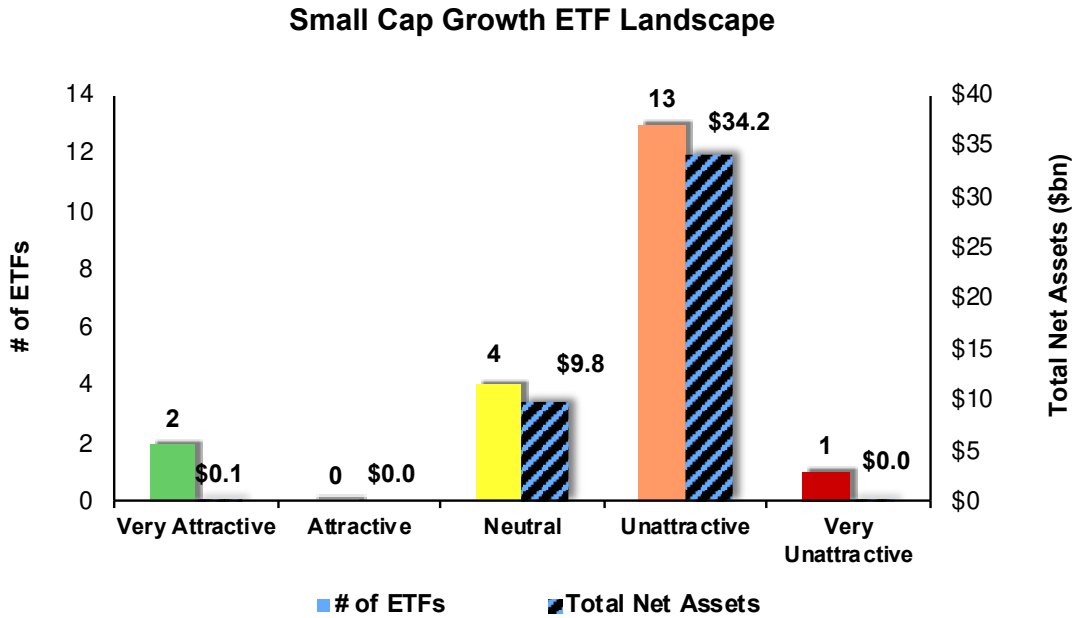

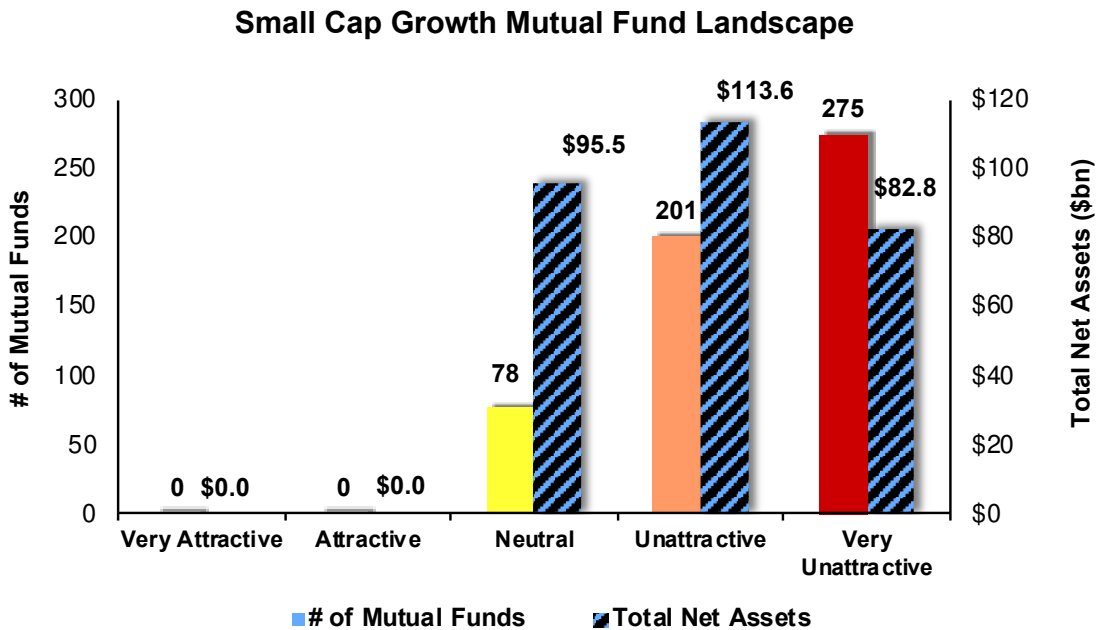
