



ETF & Mutual Fund Rankings: All Cap Blend Style

The All Cap Blend style ranks fourth out of the twelve fund styles as detailed in our [1Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Blend style ranked third. It gets our Neutral rating, which is based on an aggregation of ratings of 144 ETFs and 805 mutual funds in the All Cap Blend style as of January 21, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 14 to 3563). This variation creates drastically different investment implications and, therefore, ratings.

ProFunds Banks UltraSector ProFund (BKPIX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

VictoryShares U.S. Multi Factor Minimum Volatility ETF (VSMV) is the top-rated All Cap Blend ETF and Horizon Active Dividend Fund (HNDDX) is the top-rated All Cap Blend mutual fund. Both earn a Very Attractive rating.

SoFi Gig Economy ETF (GIGE) is the worst rated All Cap Blend ETF and American Growth Fund Series Two (AMREX) is the worst rated All Cap Blend mutual fund. Both earn a Very Unattractive rating.

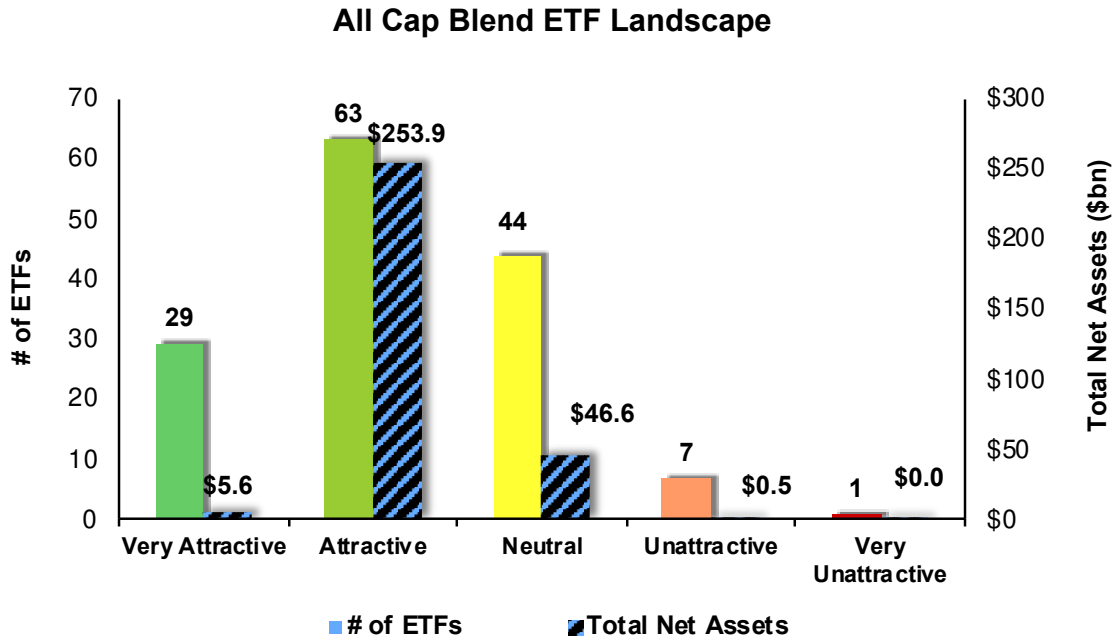

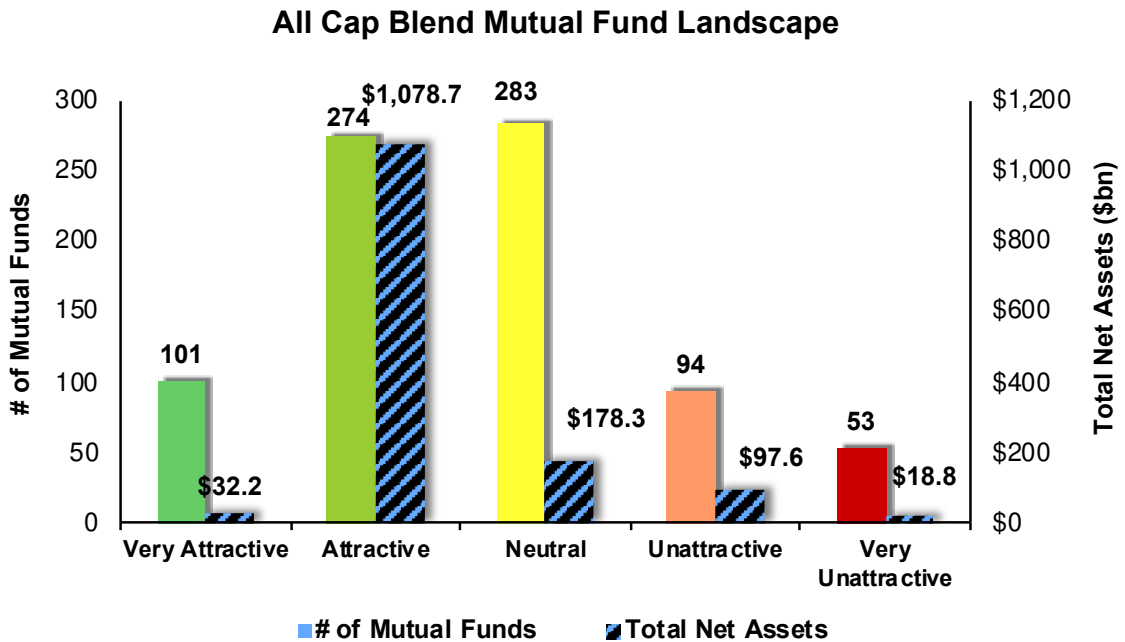


Figure 3: Separating the Best ETFs from the Worst Funds
