



ETF & Mutual Fund Rankings: All Cap Value Style

The All Cap Value style ranks first out of the twelve fund styles as detailed in our [1Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Value style ranked fourth. It gets our Very Attractive rating, which is based on an aggregation of ratings of 43 ETFs and 433 mutual funds in the All Cap Value style as of January 23, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 17 to 1611). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the All Cap Value style should buy one of the Very Attractive rated ETFs or mutual funds from Figures 1 and 2.

Pacer US Cash Cows 100 ETF (COWZ) is the top-rated All Cap Value ETF and DWS CROCI US Fund (DCURX) is the top-rated All Cap Value mutual fund. Both earn a Very Attractive rating.

First Trust Dorsey Wright Momentum & Low Volatility ETF (DVOL) is the worst rated All Cap Value ETF and Castle Focus Fund (CASTX) is the worst rated All Cap Value mutual fund. DVOL earns an Unattractive rating and CASTX earns a Very Unattractive rating.

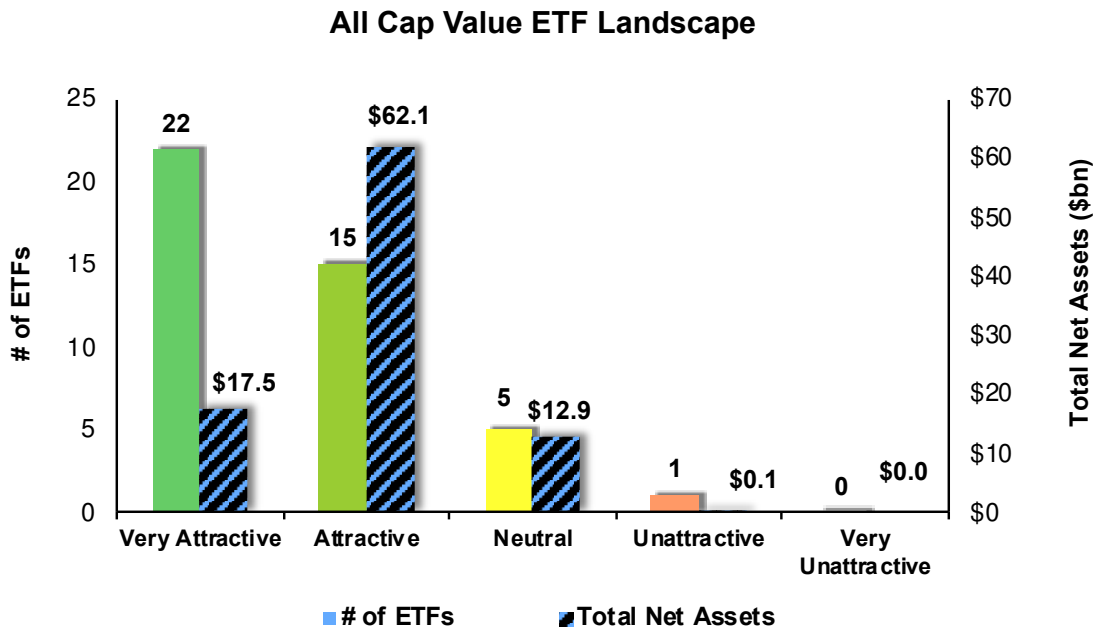

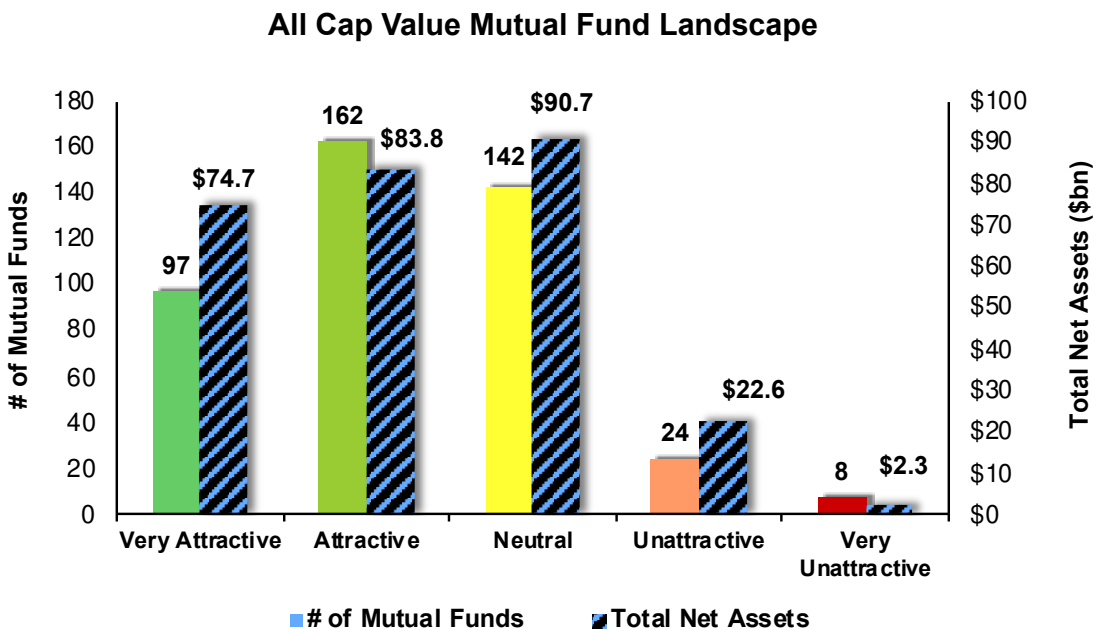
