ETF & Mutual Fund Rankings: Healthcare Sector

The Healthcare sector ranks sixth out of the 11 sectors as detailed in our <u>1Q20 Sector Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Healthcare sector ranked seventh. It gets our Neutral rating, which is based on an aggregation of ratings of the 365 stocks in the Healthcare sector as of January 11, 2020. See a recap of our <u>4Q19 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Healthcare sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 24 to 398). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Healthcare sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

Five mutual funds (MEDRX, ICHCX, SBHIX, KRXCX, LOGSX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

PJP is the top-rated Healthcare ETF and SWHFX is the top-rated Healthcare mutual fund. PJP earns a Very Attractive rating and SWHFX earns an Attractive rating.

FBT is the worst rated Healthcare ETF and PHLAX is the worst Healthcare mutual fund. They both earn a Very Unattractive rating.

365 stocks of the 2900+ we cover are classified as Healthcare stocks.




