



## ETF & Mutual Fund Rankings: Mid Cap Blend Style

The Mid Cap Blend style ranks fifth out of the twelve fund styles as detailed in our [1Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Mid Cap Blend style ranked sixth. It gets our Neutral rating, which is based on an aggregation of ratings of 19 ETFs and 364 mutual funds in the Mid Cap Blend style as of January 23, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Mid Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 20 to 2580). This variation creates drastically different investment implications and, therefore, ratings.

Applied Finance Dividend Fund (AFVDX, AFADX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and does not meet our liquidity minimums.

Alpha Architect US Quantitative Value ETF (QVAL) is the top-rated Mid Cap Blend ETF and Victory Sycamore Established Value Fund (VEVRX) is the top-rated Mid Cap Blend mutual fund. Both earn a Very Attractive rating.

Invesco Raymond James SB-1 Equity ETF (RYJ) is the worst rated Mid Cap Blend ETF and Quantified All-Cap Equity Fund (QACAX) is the worst rated Mid Cap Blend mutual fund. RYJ earns an Unattractive rating and QACAX earns a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 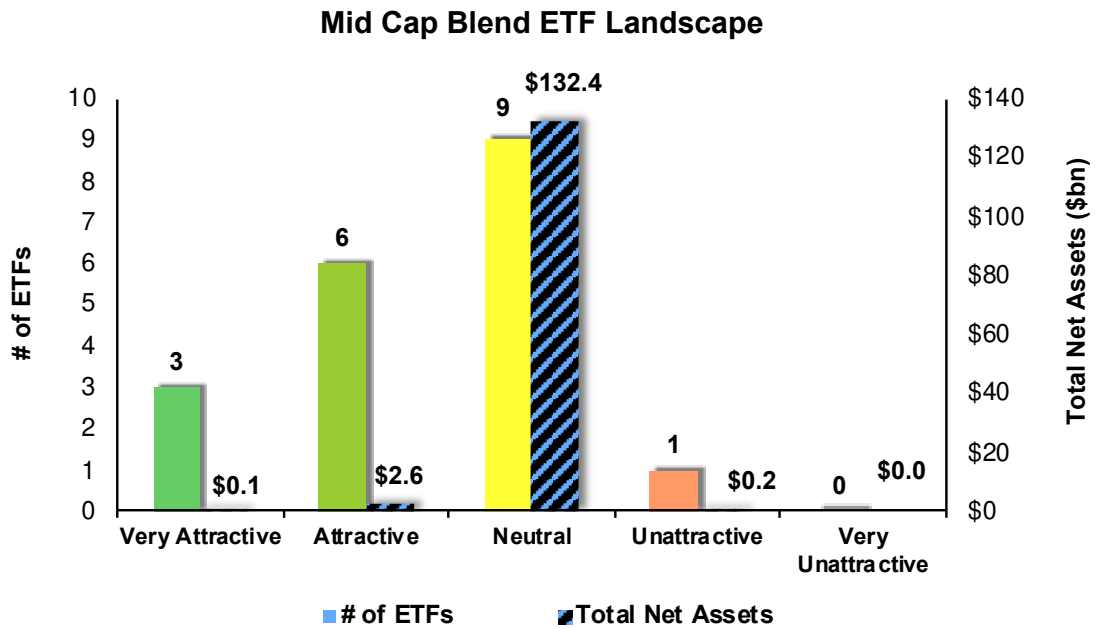

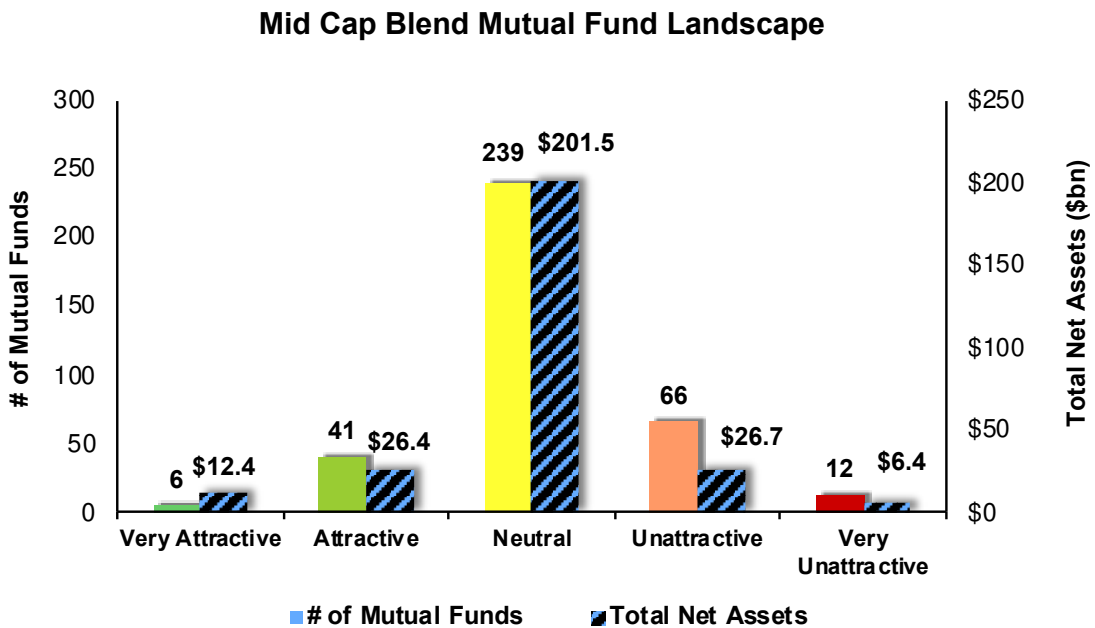
