# **ETF & Mutual Fund Rankings: Technology Sector**

The Technology sector ranks eighth out of the 11 sectors as detailed in our <u>1Q20 Sector Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Technology sector ranked sixth. It gets our Neutral rating, which is based on an aggregation of ratings of the 458 stocks in the Technology sector as of January 11, 2020. See a recap of our <u>4Q19 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Technology sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 378). This variation creates drastically different investment implications and, therefore, ratings.

Investors seeking exposure to the Technology sector should buy one of the Attractive-or-better rated ETFs or mutual funds from Figures 1 and 2.

STPIX is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

TDIV is the top-rated Technology ETF and FDCPX is the top-rated Technology mutual fund. TDIV earns a Very Attractive rating and FDCPX earns an Attractive rating.

ARKW is the worst rated Technology ETF and RSIFX is the worst Technology mutual fund. They both earn a Very Unattractive rating.

458 stocks of the 2900+ we cover are classified as Technology stocks.




