



ETF & Mutual Fund Rankings: Consumer Non-cyclicals Sector

The Consumer Non-cyclicals sector ranks first out of the 11 sectors as detailed in our [2Q20 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Consumer Non-cyclicals sector ranked second. It gets our Very Attractive rating, which is based on an aggregation of ratings of the 137 stocks in the Consumer Non-cyclicals sector as of April 11, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Non-cyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 24 to 132). This variation creates drastically different investment implications and, therefore, ratings.

XLP is the top-rated Consumer Non-cyclicals ETF and FIJCX is the top-rated Consumer Non-cyclicals mutual fund. Both earn a Very Attractive rating.

PGLOX is the worst rated Consumer Non-cyclicals mutual fund. PGLOX earns a Neutral rating.

137 stocks of the 2850+ we cover are classified as Consumer Non-cyclicals stocks.

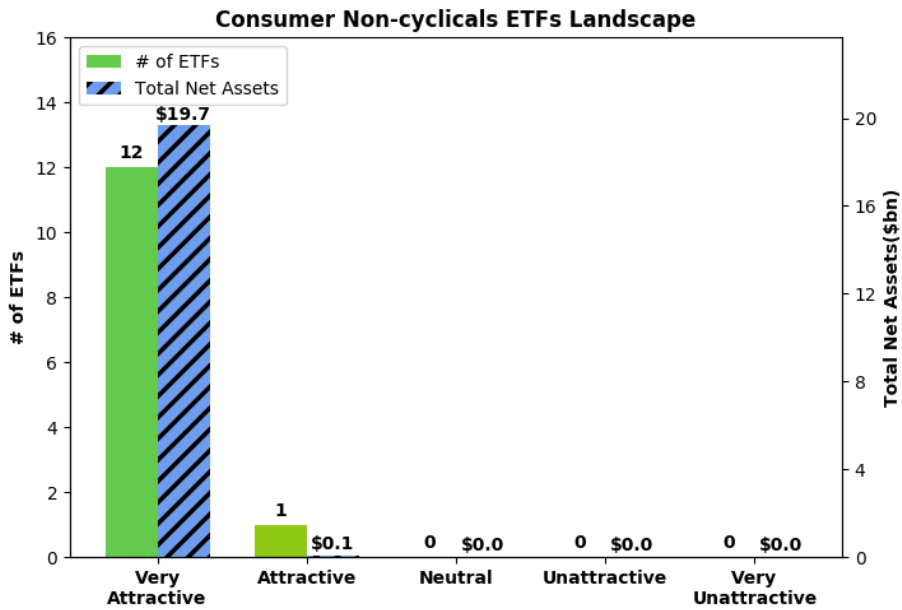

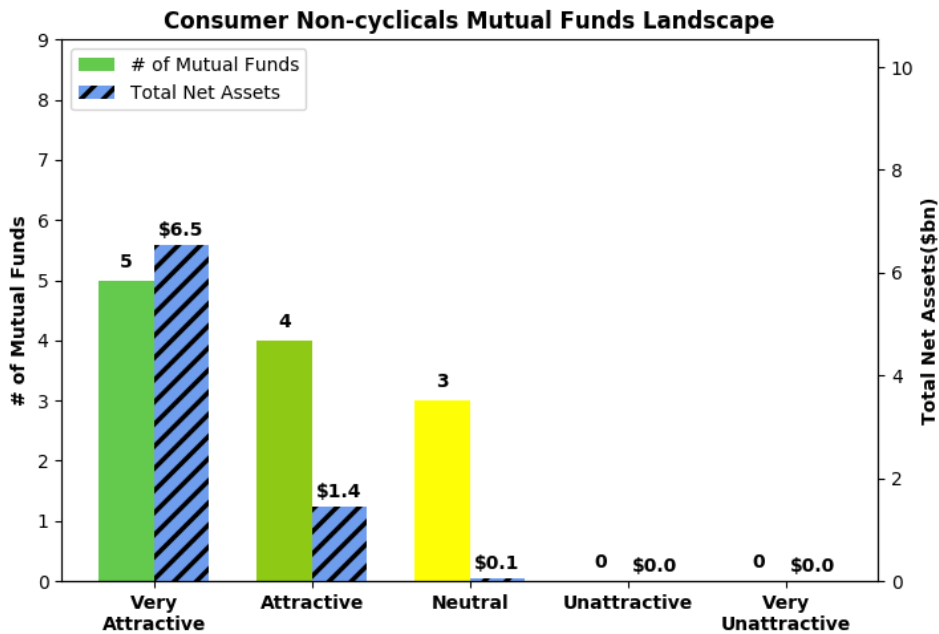
