



ETF & Mutual Fund Rankings: Energy Sector

The Energy sector ranks fifth out of the 11 sectors as detailed in our [2Q20 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Energy sector ranked fourth. It gets our Neutral rating, which is based on an aggregation of ratings of the 180 stocks in the Energy sector as of April 11, 2020. See a recap of our [1Q20 Sector Ratings here](#).

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Energy sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 213). This variation creates drastically different investment implications and, therefore, ratings.

Eight mutual funds (ICBMX, MAGRX, MCGRX, ICWIX, ICPUX, BACIX, ICBCX, BACSX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

IXC is the top-rated Energy ETF and TRNEX is the top-rated Energy mutual fund. IXC earns a Neutral rating and TRNEX earns an Attractive rating.

PSCE is the worst rated Energy ETF and RYENX is the worst rated Energy mutual fund. PSCE earns an Unattractive rating and RYENX earns a Very Unattractive rating.

180 stocks of the 2850+ we cover are classified as Energy stocks.

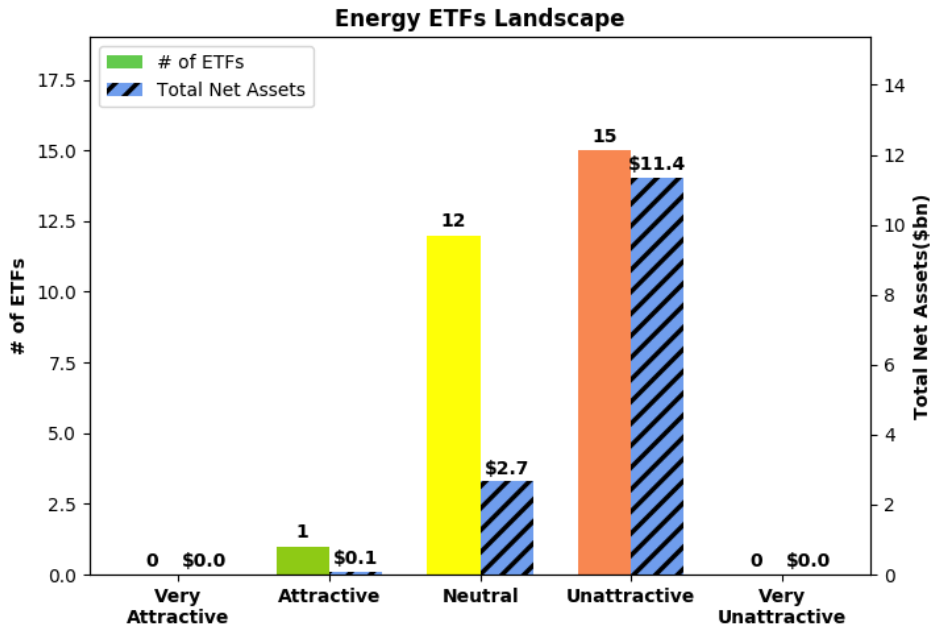

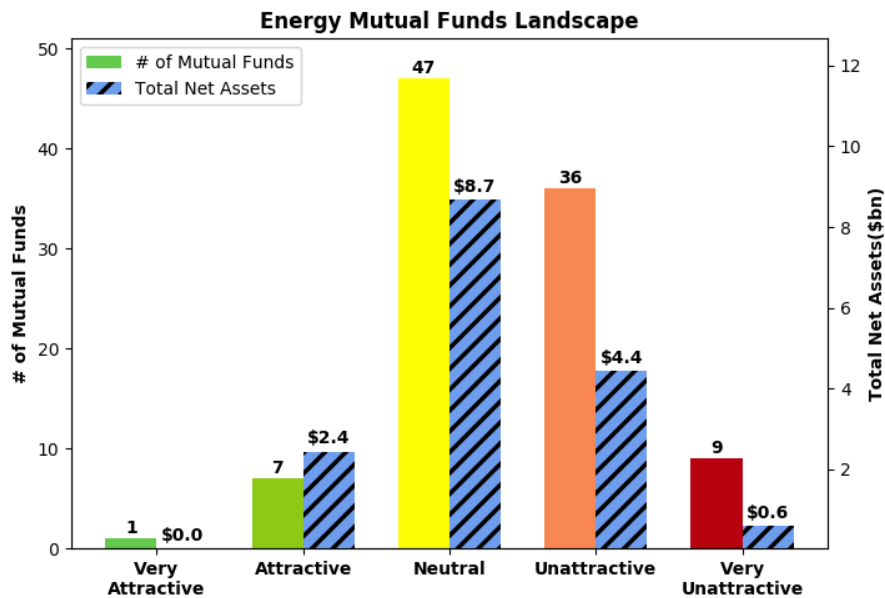
