

ETF & Mutual Fund Rankings: Financials Sector

The Financials sector ranks third out of the 11 sectors as detailed in our <u>2Q20 Sector Ratings for ETFs and</u> <u>Mutual Funds</u> report. <u>Last quarter</u>, the Financials sector ranked third. It gets our Attractive rating, which is based on an aggregation of ratings of the 438 stocks in the Financials sector as of April 11, 2020. See a recap of our <u>1Q20 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Financials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 24 to 423). This variation creates drastically different investment implications and, therefore, ratings.

KBWB is the top-rated Financials ETF and TFIFX is the top-rated Financials mutual fund. Both earn a Very Attractive rating.

KBWD is the worst rated Financials ETF and RYFNX is the worst Financials mutual fund. They both earn an Unattractive rating.

438 stocks of the 2850+ we cover are classified as Financials stocks.


PERFORMANCE OF HOLDINGs = PERFORMANCE OF FUND






Figures 3 and 4 show the rating landscape of all Financials ETFs and mutual funds.
