



ETF & Mutual Fund Rankings: All Cap Blend Style

The All Cap Blend style ranks fourth out of the twelve fund styles as detailed in our [3Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Blend style ranked fourth as well. It gets our Neutral rating, which is based on an aggregation of ratings of 116 ETFs and 755 mutual funds in the All Cap Blend style as of July 21, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 12 to 3601). This variation creates drastically different investment implications and, therefore, ratings.

Principal Active Global Dividend Income ETF (GDVD) is the top-rated All Cap Blend ETF and BNY Mellon Global Equity Income Fund (DEQYX) is the top-rated All Cap Blend mutual fund. Both earn a Very Attractive rating.

ProShares Long Online/Short Stores ETF (CLIX) is the worst rated All Cap Blend ETF and American Growth Fund Series Two (AMREX) is the worst rated All Cap Blend mutual fund. Both earn a Very Unattractive rating.

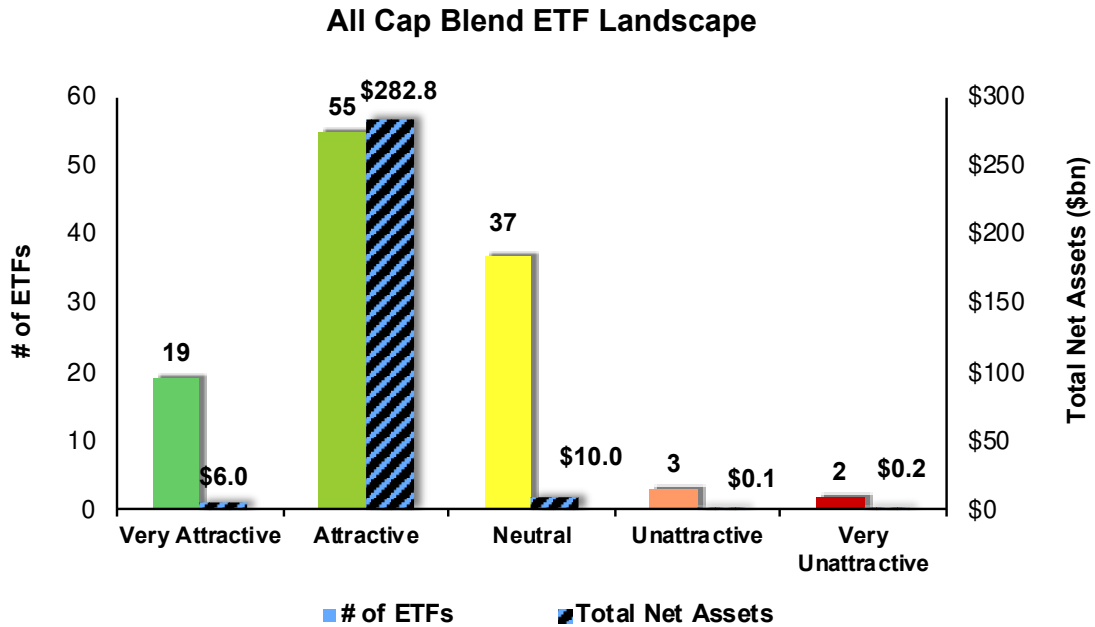

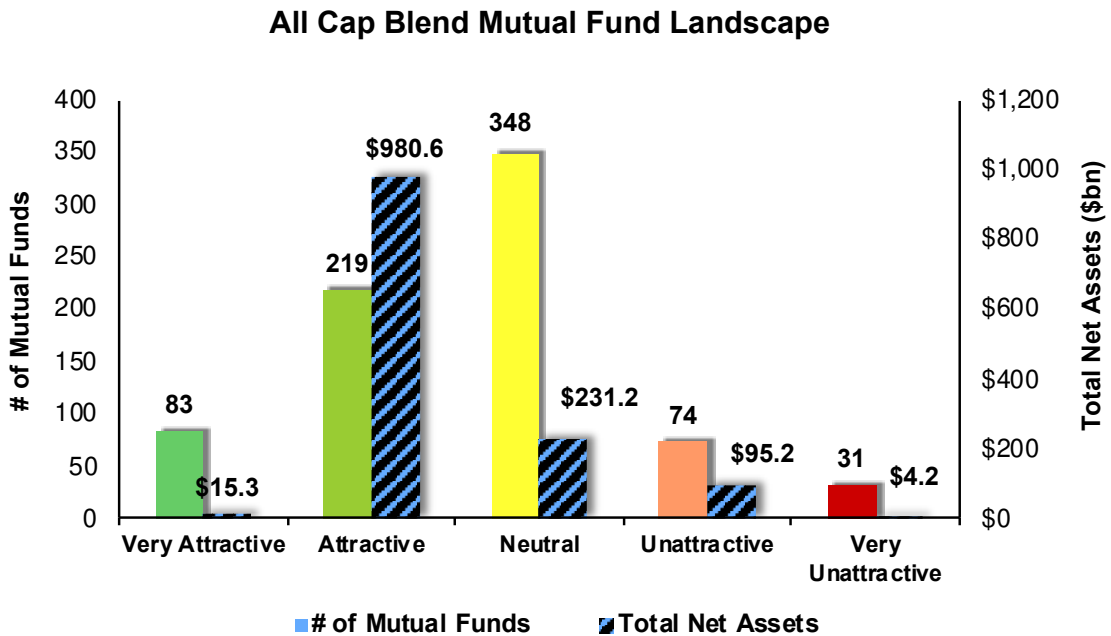
