



## ETF & Mutual Fund Rankings: Telecom Services Sector

The Telecom Services sector ranks first out of the 11 sectors as detailed in our [3Q20 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Telecom Services sector ranked second. It gets our Very Attractive rating, which is based on an aggregation of ratings of the 37 stocks in the Telecom Services sector as of July 11, 2020. See a recap of our [2Q20 Sector Ratings here](#).

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Telecom Services sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 21 to 114). This variation creates drastically different investment implications and, therefore, ratings.

Ten mutual funds (RYMIX, RYMAX, RYCSX, FLICX, FTICX, RYTLX, FONMX, FONLX, FNETX, WIREX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

IXP is the top-rated Telecom Services ETF and VTCAX is the top-rated Telecom Services mutual fund. IXP earns a Very Attractive rating and VTCAX earns an Attractive rating.

JHCS is the worst rated Telecom Services ETF and FTUAX is the worst rated Telecom Services mutual fund. JHCS earns an Unattractive rating and FTUAX earns a Very Unattractive rating.

37 stocks of the 2850+ we cover are classified as Telecom Services stocks.

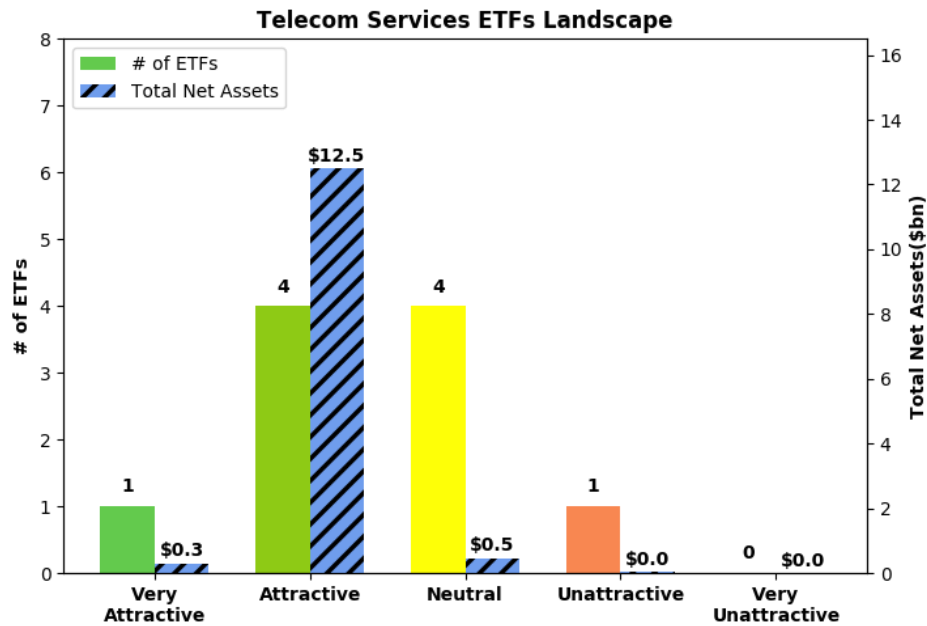

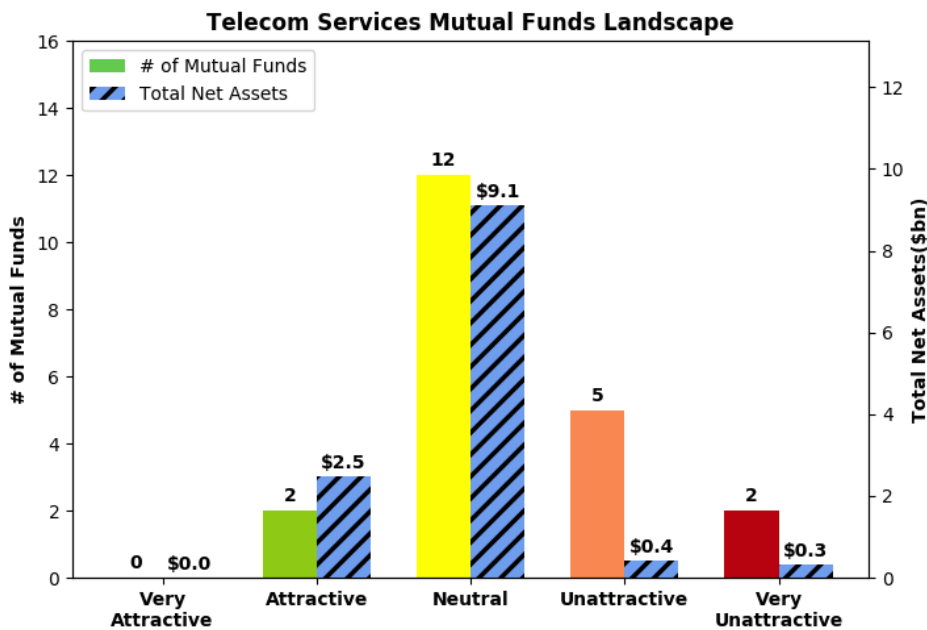
