



## ETF & Mutual Fund Rankings: Utilities Sector

The Utilities sector ranks tenth out of the 11 sectors as detailed in our [3Q20 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Utilities sector ranked tenth. It gets our Unattractive rating, which is based on an aggregation of ratings of the 70 stocks in the Utilities sector as of July 11, 2020. See a recap of our [2Q20 Sector Ratings here](#).

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Utilities sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 22 to 218). This variation creates drastically different investment implications and, therefore, ratings.

Investors should not buy any Utilities ETFs or mutual funds because none get an Attractive-or-better rating. If you must have exposure to this sector, you should buy a basket of Attractive-or-better rated stocks and avoid paying undeserved fund fees. Active management has a [long history](#) of not paying off.

RYU is the top-rated Utilities ETF and FIUX is the top-rated Utilities mutual fund. Both earn a Neutral rating.

PSCU is the worst rated Utilities ETF and GAUAX is the worst rated Utilities mutual fund. PSCU earns an Unattractive rating and GAUAX earns a Very Unattractive rating.

70 stocks of the 2850+ we cover are classified as Utilities stocks.

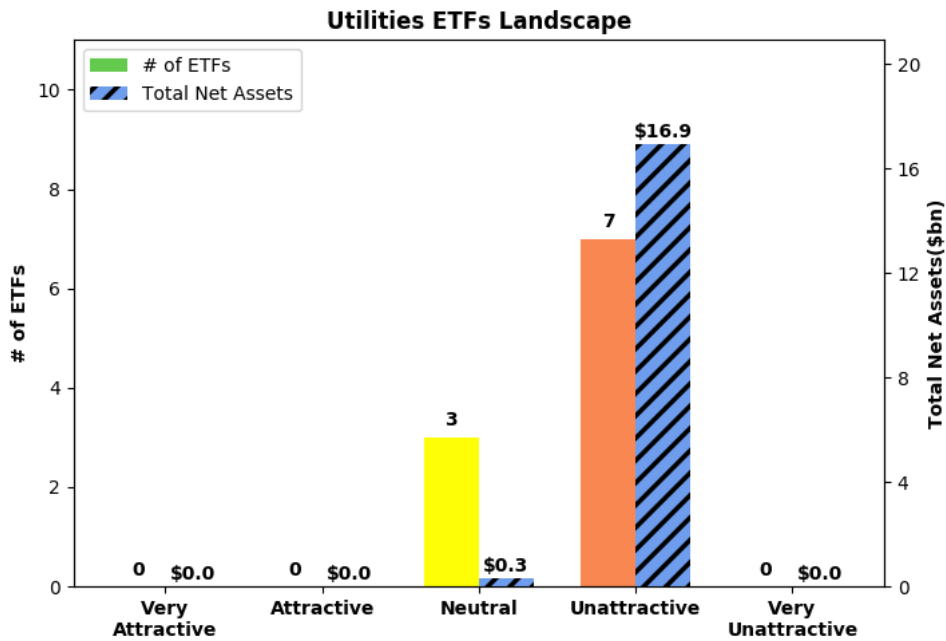

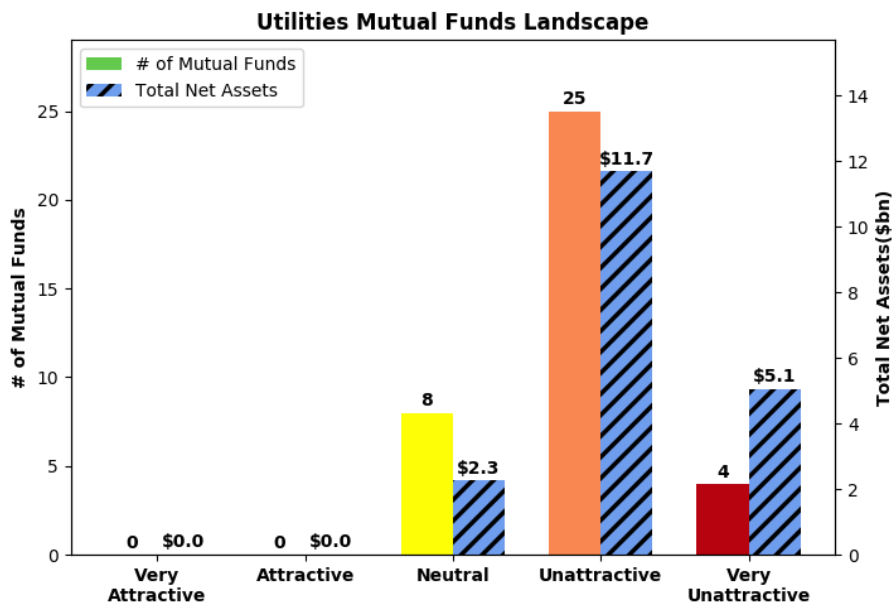
