

# ETF & Mutual Fund Rankings: Consumer Non-cyclicals Sector

The Consumer Non-cyclicals sector ranks first out of the 11 sectors as detailed in our <u>4Q20 Sector Ratings for</u> <u>ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Consumer Non-cyclicals sector ranked second. It gets our Very Attractive rating, which is based on an aggregation of ratings of the 135 stocks in the Consumer Non-cyclicals sector as of October 12, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Noncyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 24 to 125). This variation creates drastically different investment implications and, therefore, ratings.

KXI is the top-rated Consumer Non-cyclicals ETF and VCSAX is the top-rated Consumer Non-cyclicals mutual fund. Both earn a Very Attractive rating.

PSL is the worst rated Consumer Non-cyclicals ETF and FSAVX is the worst Consumer Non-cyclicals mutual fund. They both earn a Neutral rating.

135 stocks of the 2850+ we cover are classified as Consumer Non-cyclicals stocks.




