



ETF & Mutual Fund Rankings: Large Cap Value Style

The Large Cap Value style ranks first out of the twelve fund styles as detailed in our [4Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Large Cap Value style ranked first as well. It gets our Very Attractive rating, which is based on an aggregation of ratings of 66 ETFs and 752 mutual funds in the Large Cap Value style as of October 19, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Large Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 20 to 905). This variation creates drastically different investment implications and, therefore, ratings.

FlexShares Quality Dividend Index Fund (QDF) is the top-rated Large Cap Value ETF and Ariel Global Fund (AGLYX) is the top-rated Large Cap Value mutual fund. Both earn a Very Attractive rating.

Invesco S&P 500 High Dividend Low Volatility ETF (SPHD) is the worst rated Large Cap Value ETF and Upright Growth & Income Fund (UPDDX) is the worst rated Large Cap Value mutual fund. SPHD earns a Neutral rating and UPDDX earns a Very Unattractive rating.

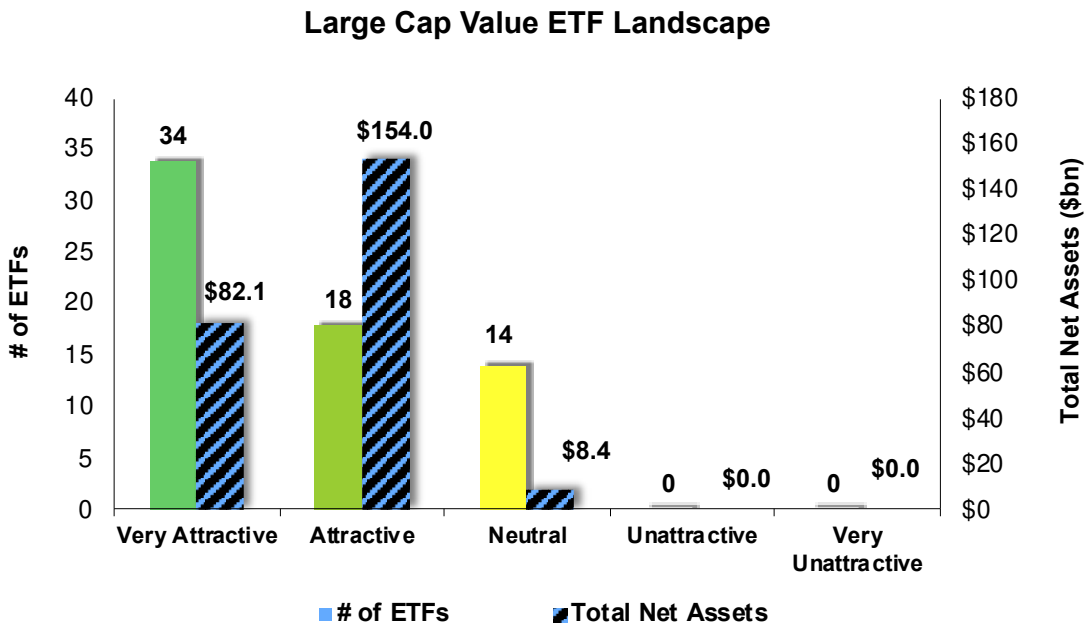

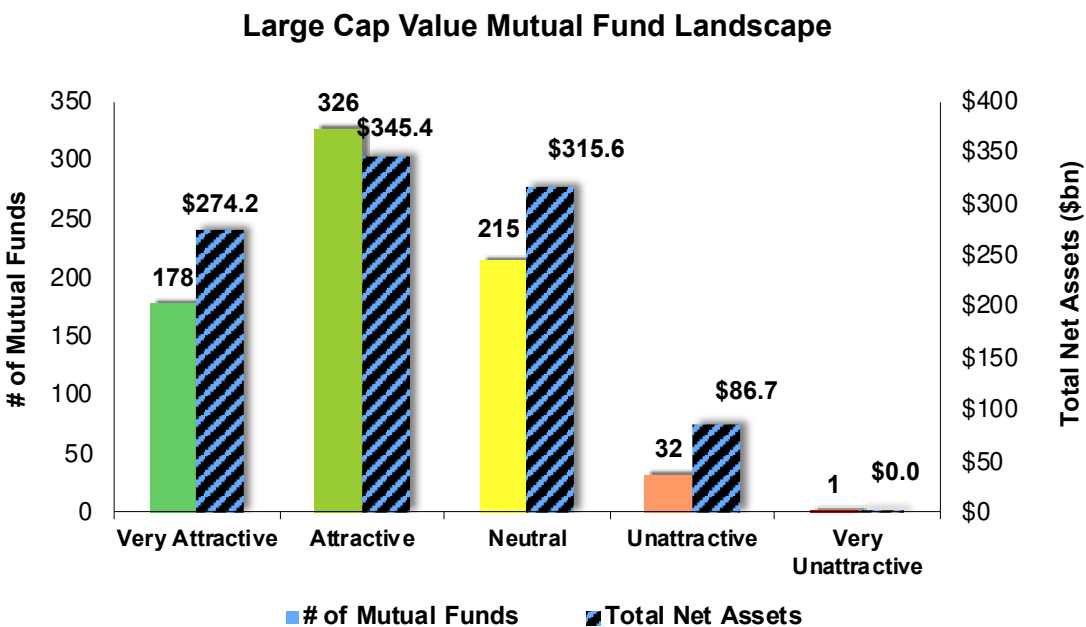
