



ETF & Mutual Fund Rankings: Small Cap Growth Style

The Small Cap Growth style ranks last out of the twelve fund styles as detailed in our [4Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Small Cap Growth style ranked last as well. It gets our Very Unattractive rating, which is based on an aggregation of ratings of 20 ETFs and 524 mutual funds in the Small Cap Growth style as of October 21, 2020. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Small Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 28 to 3213). This variation creates drastically different investment implications and, therefore, ratings.

State Street SPDR S&P 400 Mid Cap Growth ETF (MDYG) is the top-rated Small Cap Growth ETF and AMG GW&K Small/Mid Cap Fund (GWGZX) is the top-rated Small Cap Growth mutual fund. MDYG earns a Neutral rating and GWGZX earns an Attractive rating.

RBB MFAM Small Cap Growth ETF (MFMS) is the worst rated Small Cap Growth ETF and [Dunham Small Cap Growth Fund](#) (DADGX) is the worst rated Small Cap Growth mutual fund. Both earn a Very Unattractive rating.

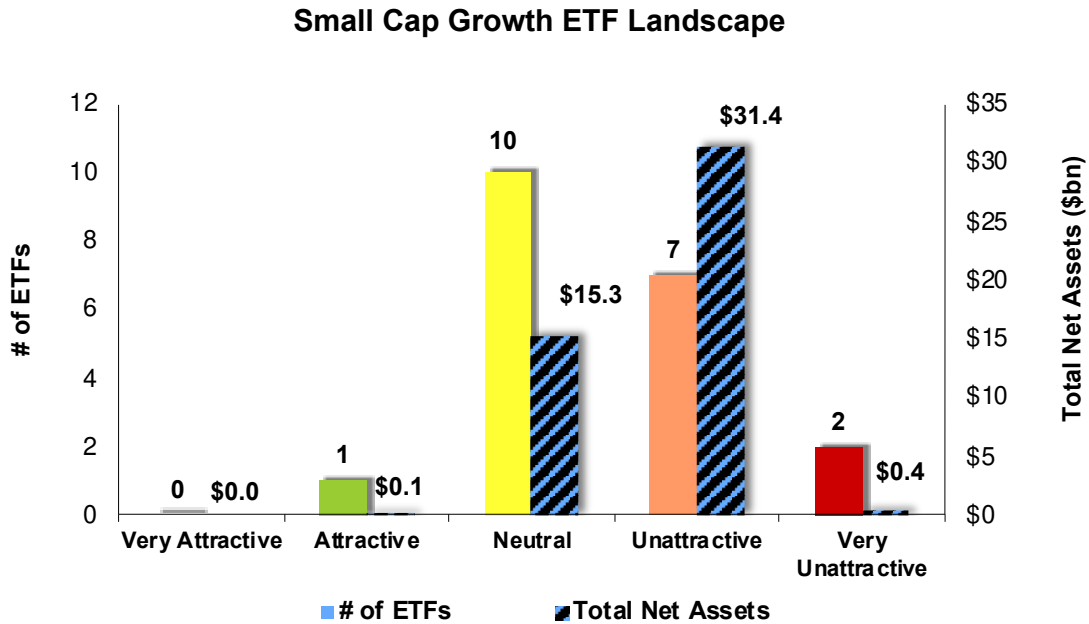

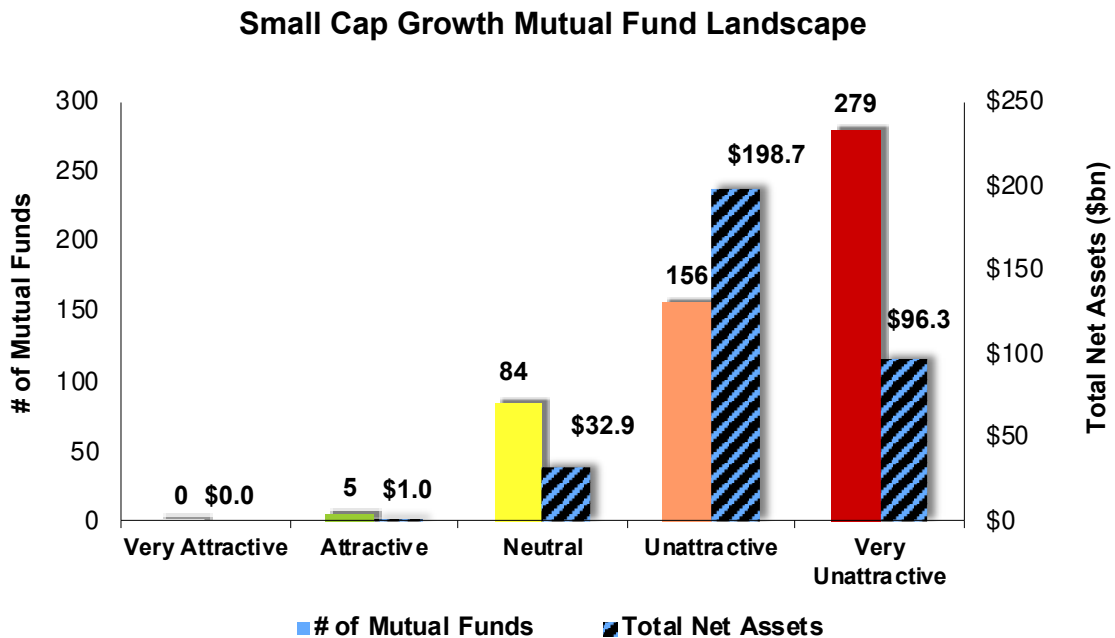
