



## ETF & Mutual Fund Rankings: Small Cap Value Style

The Small Cap Value style ranks eighth out of the twelve fund styles as detailed in our [4Q20 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Small Cap Value style ranked eighth as well. It gets our Neutral rating, which is based on an aggregation of ratings of 19 ETFs and 171 mutual funds in the Small Cap Value style as of October 21, 2020. Figure 1 ranks from best to worst the nine Small Cap Value ETFs that meet our liquidity standards and Figure 2 shows the five best and worst rated Small Cap Value mutual funds. Not all Small Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 17 to 1468). This variation creates drastically different investment implications and, therefore, ratings.

Avantais U.S. Small Cap Value ETF (AVUV) is the top-rated Small Cap Value ETF and Dean Small Cap Value Fund (DASCX) is the top-rated Small Cap Value mutual fund. Both earn an Attractive rating.

iShares S&P Small-Cap 600 Value ETF (IJS) is the worst rated Small Cap Value ETF and Transamerica Small Cap Value (TSLAX) is the worst rated Small Cap Value mutual fund. IJS earns an Unattractive rating and TSLAX earns a Very Unattractive rating.

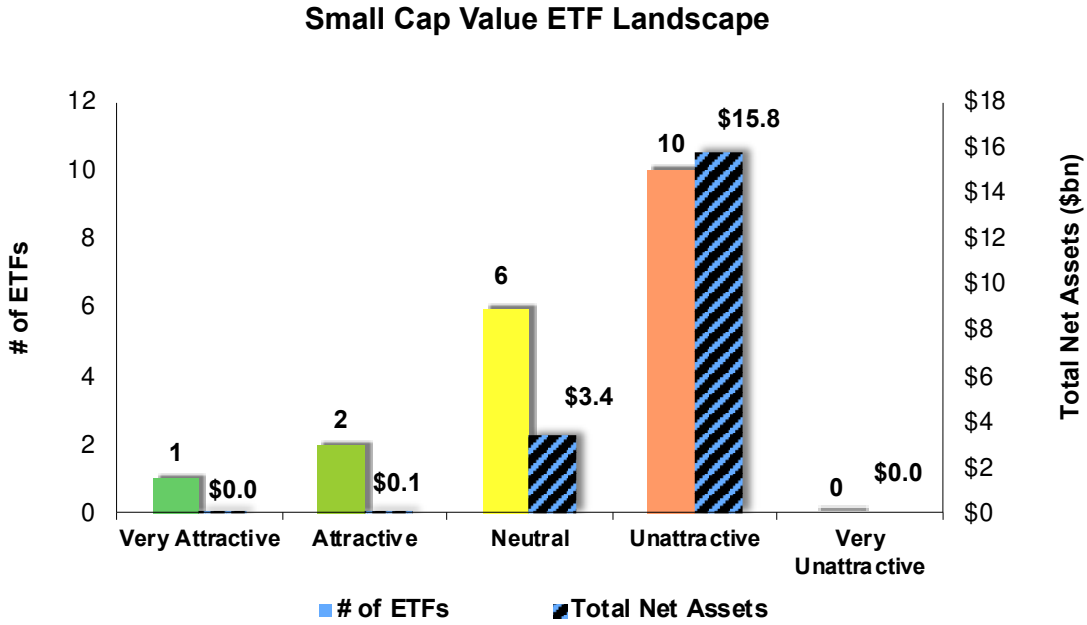

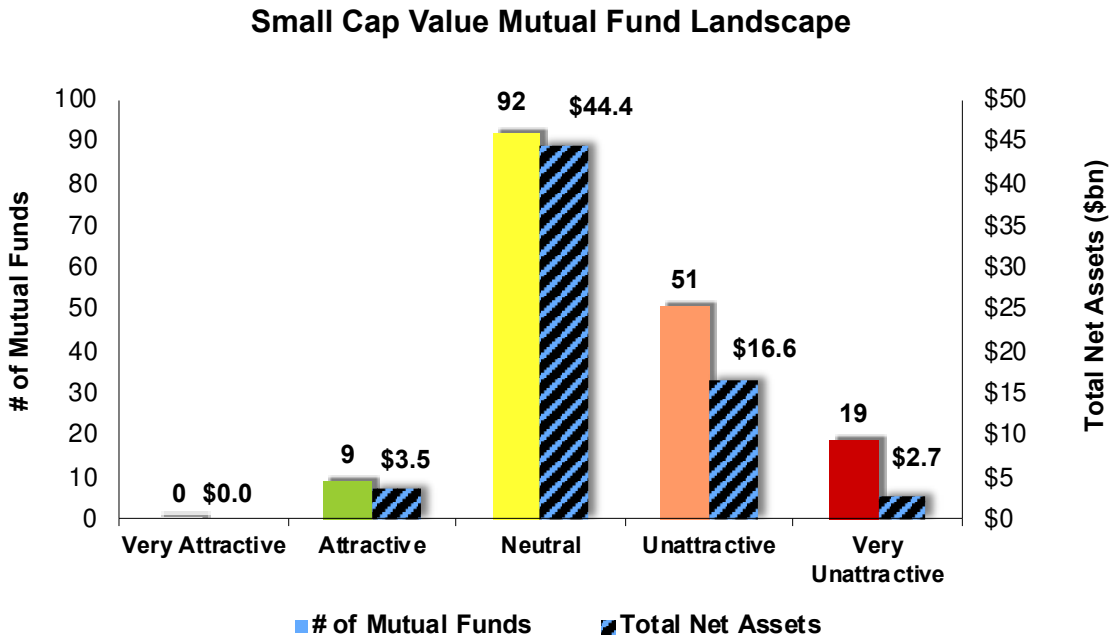
