ETF & Mutual Fund Rankings: Large Cap Growth Style

The Large Cap Growth style ranks fifth out of the twelve fund styles as detailed in our 1Q21 Style Ratings for ETFs and Mutual Funds report. Last quarter, the Large Cap Growth style ranked sixth. It gets our Neutral rating, which is based on an aggregation of ratings of 24 ETFs and 795 mutual funds in the Large Cap Growth style as of January 21, 2020. Figures 1 and 2 show the best and worst rated ETFs and mutual funds in the style. Not all Large Cap Growth style ETFs and mutual funds are created the same. The number of holdings varies widely (from 19 to 693). This variation creates drastically different investment implications and, therefore, ratings.

Seven mutual funds (DVRUX, MLNSX, MLNIX, MLNCX, JGQYX, JGQIX, JGQSX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

iShares Core S&P U.S. Growth ETF (IUSG) is the top-rated Large Cap Growth ETF and DFA U.S. Large Cap Growth Portfolio (DUSLX) is the top-rated Large Cap Growth mutual fund. IUSG earns an Attractive rating and DUSLX earns a Very Attractive rating.

AdvisorShares Dorsey Wright Alpha Equal Weight ETF (DWEQ) is the worst rated Large Cap Growth ETF and MassMutual Select Fundamental Growth Fund (MOTAX) is the worst rated Large Cap Growth mutual fund. DWEQ earns a Neutral rating and MOTAX earns a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund's performance is only as good as its holdings' performance. 

Figure 3: Separating the Best ETFs from the Worst Funds


Large Cap Growth ETF Landscape
