ETF & Mutual Fund Rankings: Consumer Cyclicals Sector

The Consumer Cyclicals sector ranks seventh out of the 11 sectors as detailed in our <u>2Q21 Sector Ratings for ETFs and Mutual Funds</u> report. <u>Last quarter</u>, the Consumer Cyclicals sector ranked sixth. It gets our Neutral rating, which is based on an aggregation of ratings of the 431 stocks in the Consumer Cyclicals sector as of April 11, 2021. See a recap of our <u>1Q21 Sector Ratings here</u>.

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Consumer Cyclicals sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 25 to 297). This variation creates drastically different investment implications and, therefore, ratings.

ITB is the top-rated Consumer Cyclicals ETF and VCDAX is the top-rated Consumer Cyclicals mutual fund. ITB earns a Very Attractive rating and VCDAX earns a Neutral rating.

BUYZ is the worst rated Consumer Cyclicals ETF and RYRTX is the worst Consumer Cyclicals mutual fund. They both earn a Very Unattractive rating.

431 stocks of the 2800+ we cover are classified as Consumer Cyclicals stocks.




