



ETF & Mutual Fund Rankings: Healthcare Sector

The Healthcare sector ranks second out of the 11 sectors as detailed in our [2Q21 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Healthcare sector ranked seventh. It gets our Attractive rating, which is based on an aggregation of ratings of the 351 stocks in the Healthcare sector as of April 11, 2021. See a recap of our [1Q21 Sector Ratings here](#).

Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the sector. Not all Healthcare sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 24 to 444). This variation creates drastically different investment implications and, therefore, ratings.

PPH is the top-rated Healthcare ETF and PGHAX is the top-rated Healthcare mutual fund. Both earn a Very Attractive rating.

FBT is the worst rated Healthcare ETF and KRXAX is the worst Healthcare mutual fund. They both earn a Very Unattractive rating.

351 stocks of the 2800+ we cover are classified as Healthcare stocks.

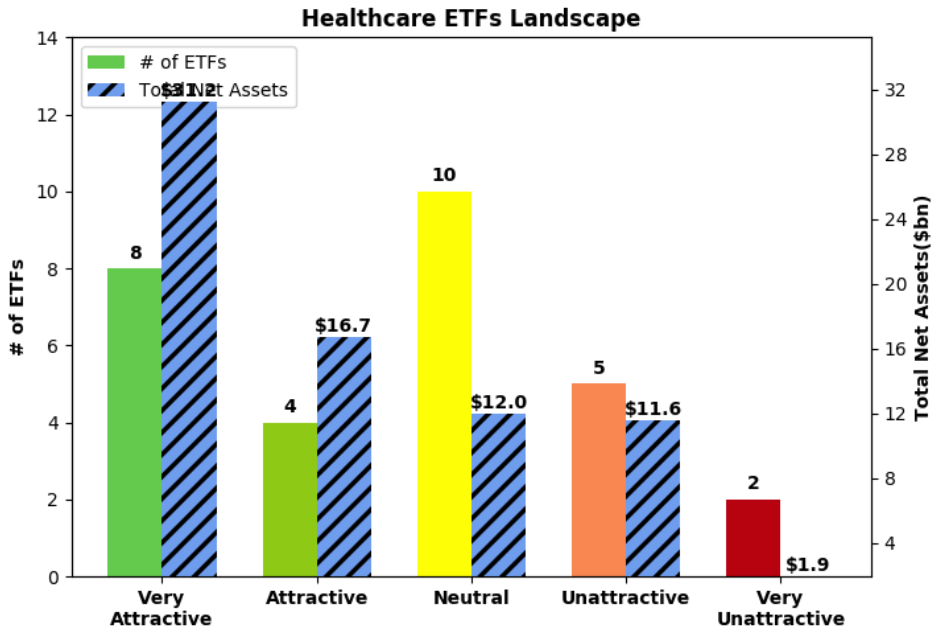

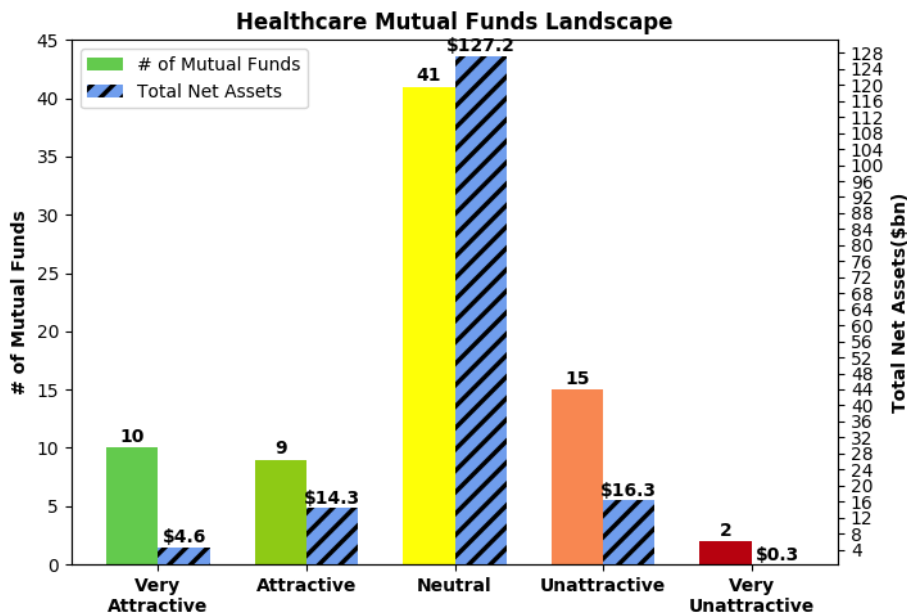
