



## ETF & Mutual Fund Rankings: Large Cap Blend Style

The Large Cap Blend style ranks second out of the twelve fund styles as detailed in our [2Q21 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Large Cap Blend style ranked second as well. It gets our Attractive rating, which is based on an aggregation of ratings of 87 ETFs and 649 mutual funds in the Large Cap Blend style as of April 21, 2021. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all Large Cap Blend style ETFs and mutual funds are created the same. The number of holdings varies widely (from 14 to 1,929). This variation creates drastically different investment implications and, therefore, ratings.

Gotham Enhanced S&P 500 Index Fund (GSPFX) is excluded from Figure 2 because its total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

FlexShares STOXX Global ESG Impact Index Fund (ESGG) is the top-rated Large Cap Blend ETF and Virtus KAR Equity Income Fund (VECRX) is the top-rated Large Cap Blend mutual fund. Both earn a Very Attractive rating.

Pacer Lunt Large Cap Alternator ETF (ALTL) is the worst rated Large Cap Blend ETF and Aberdeen U.S. Sustainable Leaders Smaller Companies Fund (MLSAX) is the worst rated Large Cap Blend mutual fund. ALTL earns an Unattractive rating and MLSAX earns a Very Unattractive rating.

Put another way, research on fund holdings is necessary due diligence because a fund’s performance is only as good as its holdings’ performance. 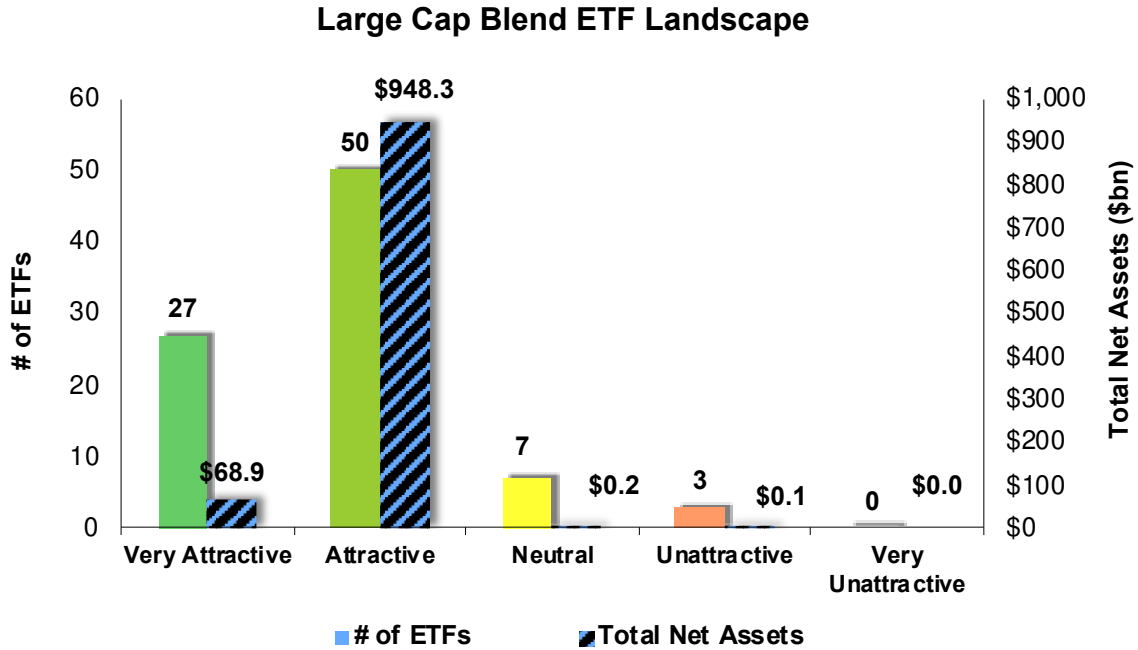

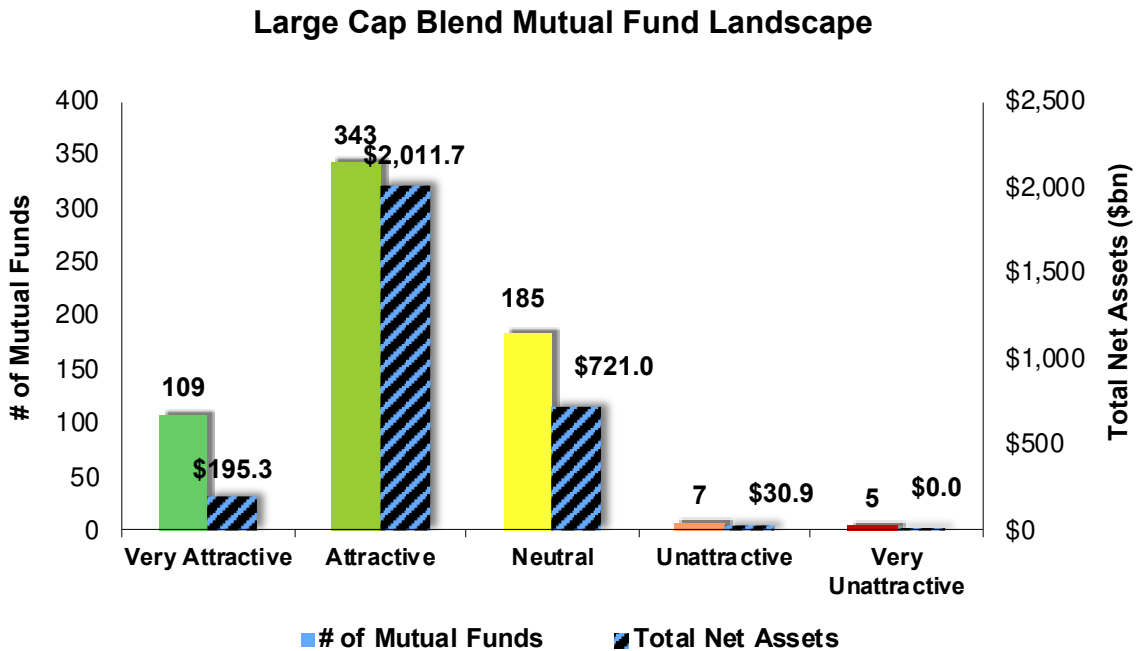


Figure 3: Separating the Best ETFs from the Worst Funds
