



## ETF & Mutual Fund Rankings: All Cap Value Style

The All Cap Value style ranks second out of the twelve fund styles as detailed in our [3Q21 Style Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the All Cap Value style ranked fourth. It gets our Attractive rating, which is based on an aggregation of ratings of 97 ETFs and 950 mutual funds in the All Cap Value style as of July 14, 2021. Figures 1 and 2 show the five best and worst rated ETFs and mutual funds in the style. Not all All Cap Value style ETFs and mutual funds are created the same. The number of holdings varies widely (from 16 to 1,784). This variation creates drastically different investment implications and, therefore, ratings.

VictoryShares U.S. Multi-Factor Minimum Volatility ETF (VSMV) is the top-rated All Cap Value ETF and [DWS CROCI U.S. Fund](#) (DCURX) is the top-rated All Cap Value mutual fund. Both earn a Very Attractive rating.

ProShares Equities for Rising Rates ETF (EQRR) is the worst rated All Cap Value ETF and Longleaf Partners Fund (LLPFX) is the worst rated All Cap Value mutual fund. EQRR earns an Unattractive Rating and LLPFX earns a Very Unattractive rating.

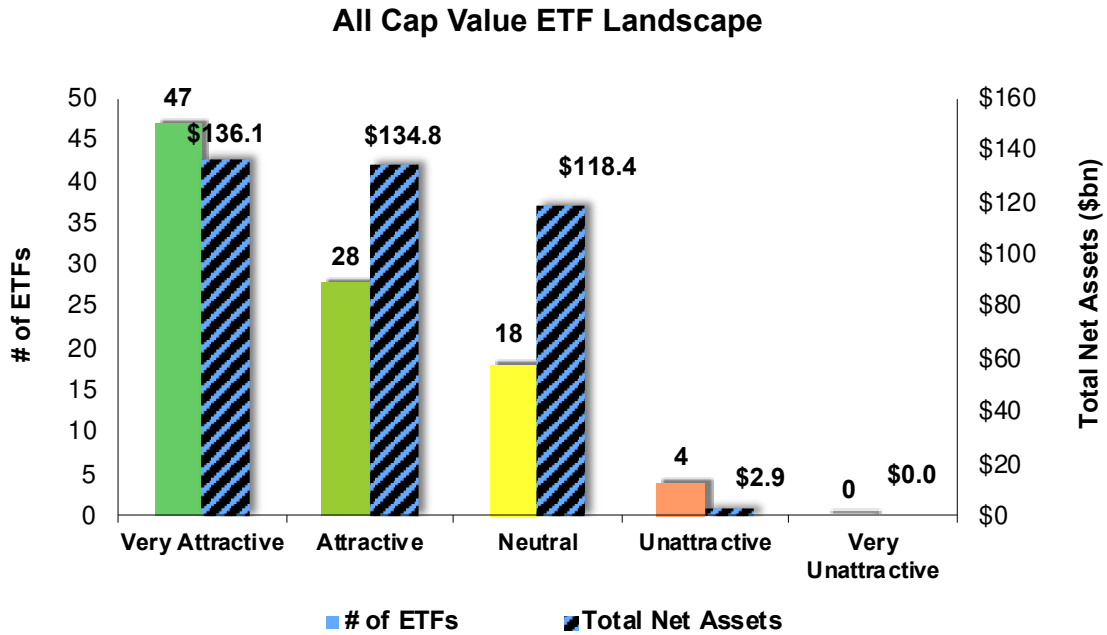

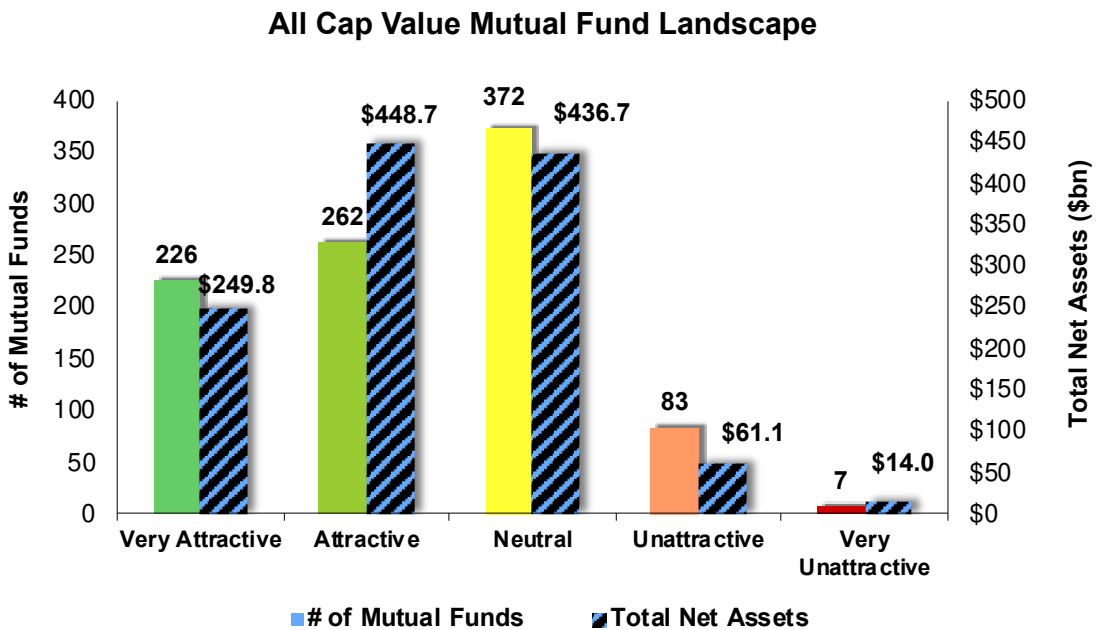
