



ETF & Mutual Fund Rankings: Financials Sector

The Financials sector ranks ninth out of the 11 sectors as detailed in our [3Q21 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Financials sector ranked third. It gets our Unattractive rating, which is based on an aggregation of ratings of the 429 stocks in the Financials sector as of July 11, 2021. See a recap of our [2Q21 Sector Ratings here](#).

Figures 1 and 2 show the best and worst rated ETFs and mutual funds in the sector. Not all Financials sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 24 to 408). This variation creates drastically different investment implications and, therefore, ratings.

KBE is the top-rated Financials ETF and DVFX is the top-rated Financials mutual fund. Both earn a Very Attractive rating.

PFI is the worst rated Financials ETF and RYFNX is the worst rated Financials mutual fund. PFI earns a Neutral rating and RYFNX earns a Very Unattractive rating.

429 stocks of the 2800+ we cover are classified as Financials stocks.

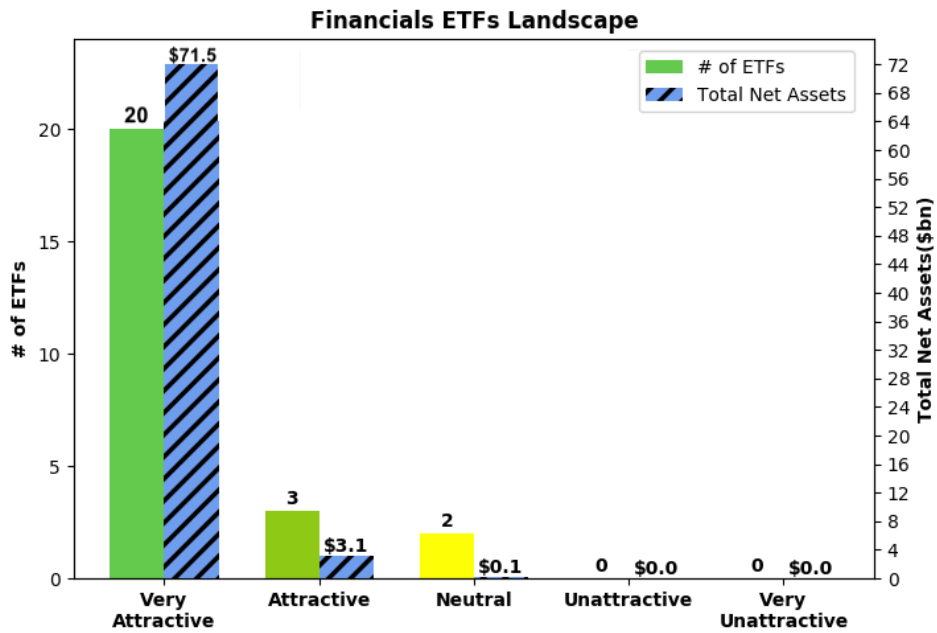

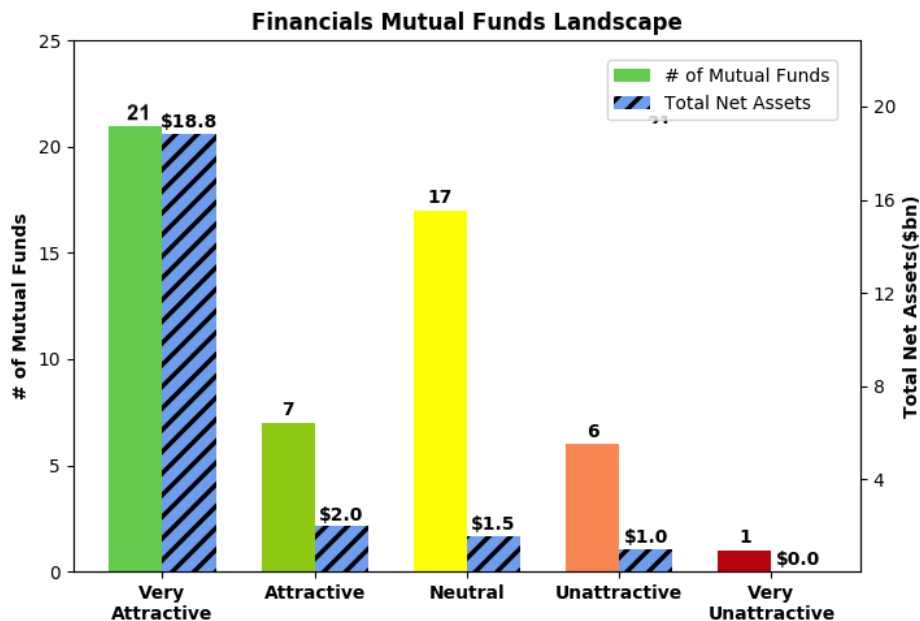
