Don't Trust Mutual Fund Labels

There are at least 179 different Real Estate mutual funds and at least 627 mutual funds across eleven sectors. Do investors need 57 choices on average per sector? How different can the mutual funds be?

Those 179 Real Estate mutual funds are very different. With anywhere from 22 to 173 holdings, many of these Real Estate mutual funds have drastically different portfolios, creating drastically different investment implications.

The same is true for the mutual funds in any other sector, as each offers a very different mix of good and bad stocks. Consumer Non-cyclicals ranks first for stock selection. Real Estate ranks last. Details on the Best & Worst mutual funds in each sector are here.

How to Avoid Paralysis by Analysis

We think the large number of Real Estate (or any other) sector mutual funds hurts investors more than it helps because too many options can be paralyzing. It is simply not possible for the majority of investors to properly assess the quality of so many mutual funds. Analyzing mutual funds, done with the proper diligence¹, is far more difficult than analyzing stocks because it means analyzing all the stocks within each mutual fund. As stated above, that can be as many as 173 stocks, and sometimes even more, for one mutual fund.

Anyone focused on <u>fulfilling the fiduciary duty of care</u> recognizes that analyzing the holdings² of a mutual fund is critical to finding the best mutual fund. More reliable & <u>proprietary</u> fundamental data, proven in <u>The Journal of Financial Economics</u>, drives our research and analysis of fund holdings. Figure 1 shows our top rated mutual fund for each sector.

Amongst the mutual funds in Figure 1, Fidelity Advisor Consumer Staples Fund (FIJCX) ranks first overall, Fidelity Health Care Services Portfolio (FSHCX) ranks second, and Davis Financial Fund (DVFYX) ranks third. Cohen & Steers Institutional Realty Shares (CSRIX) ranks last.

Fidelity Advisors Consumer Staples Fund (FIJCX) is not only the top-rated Consumer Non-cyclicals mutual fund, but is also the overall top-ranked sector mutual fund out of the 627 sector mutual funds that we cover.

The worst mutual fund in Figure 1 is Cohen & Steers Institutional Realty Shares (CSRIX), which gets an Unattractive rating. One would think mutual fund providers could do better for this sector.
