



ETF & Mutual Fund Rankings: Real Estate Sector

The Real Estate sector ranks eleventh out of the 11 sectors as detailed in our [3Q21 Sector Ratings for ETFs and Mutual Funds](#) report. [Last quarter](#), the Real Estate sector ranked eleventh as well. It gets our Very Unattractive rating, which is based on an aggregation of ratings of the 195 stocks in the Real Estate sector as of July 11, 2021. See a recap of our [2Q21 Sector Ratings here](#).

Figures 1 and 2 show the best and worst rated ETFs and mutual funds in the sector. Not all Real Estate sector ETFs and mutual funds are created the same. The number of holdings varies widely (from 16 to 173). This variation creates drastically different investment implications and, therefore, ratings.

Two mutual funds (HLRRX, HLPPX) are excluded from Figure 2 because their total net assets (TNA) are below \$100 million and do not meet our liquidity minimums.

MORT is the top-rated Real Estate ETF. There are no mutual funds that receive a Neutral-or-better rating. MORT earns an Attractive rating.

INDS is the worst rated Real Estate ETF and PWREX is the worst Real Estate mutual fund. They both earn a Very Unattractive rating.

195 stocks of the 2800+ we cover are classified as Real Estate stocks.

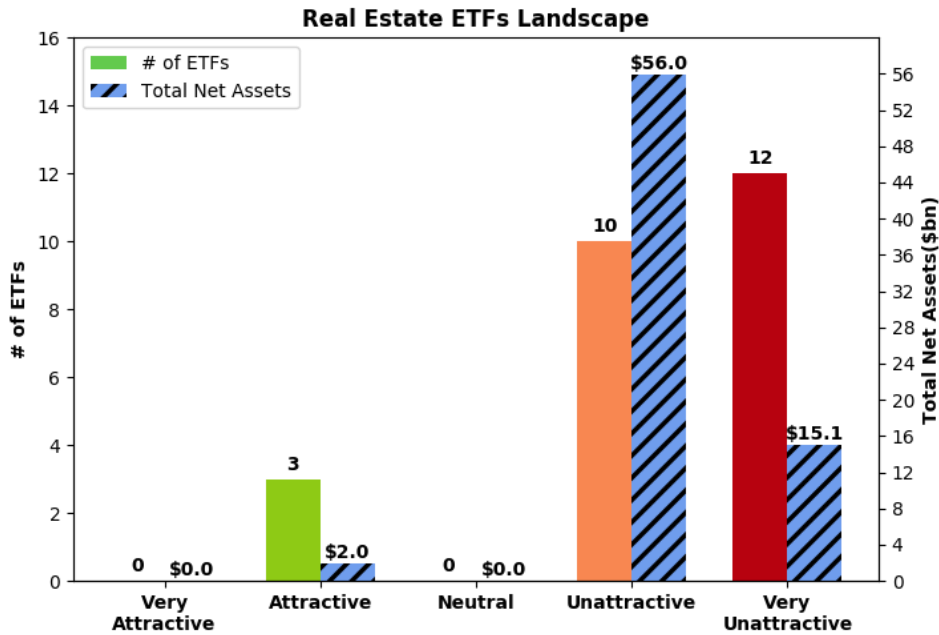

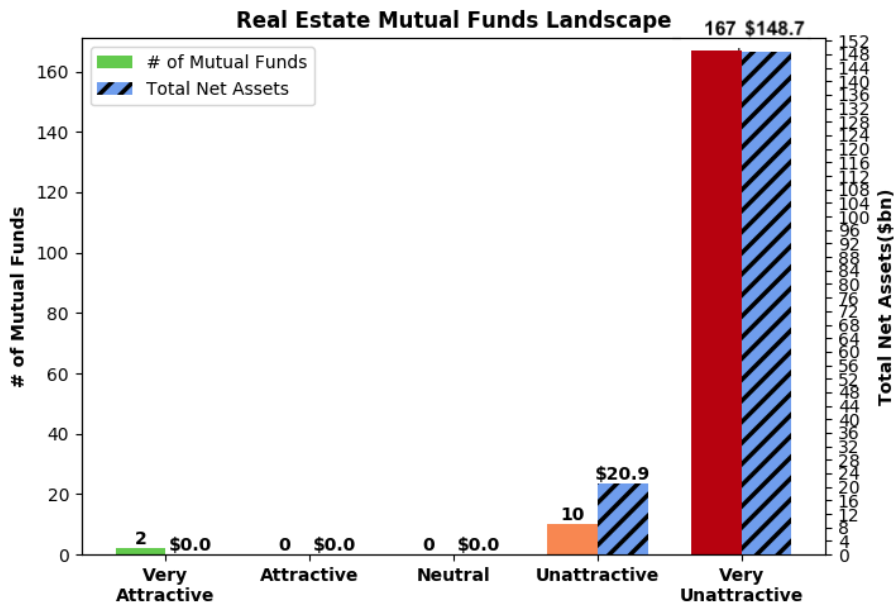
