# **How to Find the Best Style Mutual Funds**

With an ever-growing list of similar-sounding mutual funds to choose from, finding the best is an increasingly difficult task. How can investors change the game to shift the odds in their favor?

#### **Don't Trust Mutual Fund Labels**

There are at least 948 different All Cap Value mutual funds and at least 5,816 style-based mutual funds across twelve styles. Do investors need 484+ choices on average per style? How different can the mutual funds be?

Those 948 All Cap Value mutual funds are very different. With anywhere from 17 to 1,238 holdings, many of these All Cap Value mutual funds have drastically different portfolios with differing risk profiles and performance outlooks.

The same is true for the mutual funds in any other style, as each offers a very different mix of good and bad stocks. Large Cap Value ranks first for stock selection. Small Cap Growth ranks last. ### **Avoiding Analysis Paralysis**

We think the large number of style mutual funds hurts investors more than it helps. Manually conducting a deep analysis on a mutual fund-by-mutual fund basis is simply not a realistic option, exposing investors to insufficient analysis and missing profitable opportunities. Analyzing mutual funds, with the proper diligence<sup>1</sup>, is far more difficult than analyzing stocks because it means analyzing all the stocks within each mutual fund. As stated above, there can be as many as 1,238 stocks or more for one mutual fund.

Anyone focused on <u>fulfilling the fiduciary duty of care</u> recognizes that analyzing the holdings<sup>2</sup> of a mutual fund is critical to finding the best mutual fund. More <u>reliable</u> & <u>proprietary</u> fundamental data, proven in <u>The Journal of Financial Economics</u>, drives our research and analysis of fund holdings and provides investors with a <u>new source of alpha</u>. Amongst the mutual funds in Figure 1, Northern Lights FormulaFolios U.S. Equity Fund (FFILX) ranks first overall, DWS CROCI Equity Dividend Fund (KDHTX) ranks second, and Clipper Fund (CFIMX) ranks third. Virtus KAR Small Cap Core Fund (VSCRX) ranks last.

Northern Lights FormulaFolios U.S. Equity Fund (FFILX) is not only the top-rated All Cap Blend mutual fund, but is also the overall top-ranked style mutual fund out of the 5,816 style mutual funds that we cover.

The worst mutual fund in Figure 1 is Virtus KAR Small Cap Core Fund (VSCRX), which still gets an Attractive rating.
