



Focus List Stocks: Model Portfolios Outperform by 39% as a Long/Short Portfolio in 2022

The <u>long portfolio contributed 11%</u> while the <u>short portfolio contributed 28%</u> of the outperformance vs. the S&P 500 in 2022.
