



## S&P 500 Economic Earnings: Update For 3Q23 (Free, Abridged)

This report updates the trailing-twelve-months (TTM) [Economic Earnings](#) for the S&P 500 and all sectors as of 11/14/23.

Economic earnings are rising for some sectors and falling in others, and the magnitude of change varies by a wide margin. Trailing TTM Economic Earnings in 3Q23 were lower than 2Q23 TTM levels for eight of eleven sectors.

### Economic Earnings Update For 3Q23

See Figure 1 in the [full version](#) of our report for the chart of Economic Earnings vs. GAAP earnings for the S&P 500 and each of its eleven sectors from December 2004 through 3Q23.

The S&P 500's 3Q23 Economic Earnings continue to follow the trend we foresaw in our 1Q22 report [S&P 500 Economic Earnings Set Records, but WACC Is a Drag](#). Indeed, one of the headwinds facing Economic Earnings is a rising WACC. Investors can protect themselves by paying closer attention to Economic Earnings, which account for the effects of changes to WACC.

### Key Details on Select S&P 500 Sectors

The Consumer Cyclical sector saw the largest QoQ improvement in TTM Economic Earnings.

The Technology sector's TTM Economic Earnings are the highest of any sector. On the flip side, the Utilities sector has the lowest TTM Economic Earnings of any sector and was one of eight sectors that destroyed shareholder value in 3Q23.

Below, we highlight the Consumer Cyclical sector, which saw the largest QoQ improvement in TTM Economic Earnings in 3Q23.

### Sample Sector Analysis<sup>3</sup>: Consumer Cyclical

Figure 1 shows Economic Earnings for the Consumer Cyclical sector, rose 31% QoQ in 3Q23, while GAAP earnings rose 18% over the same time.

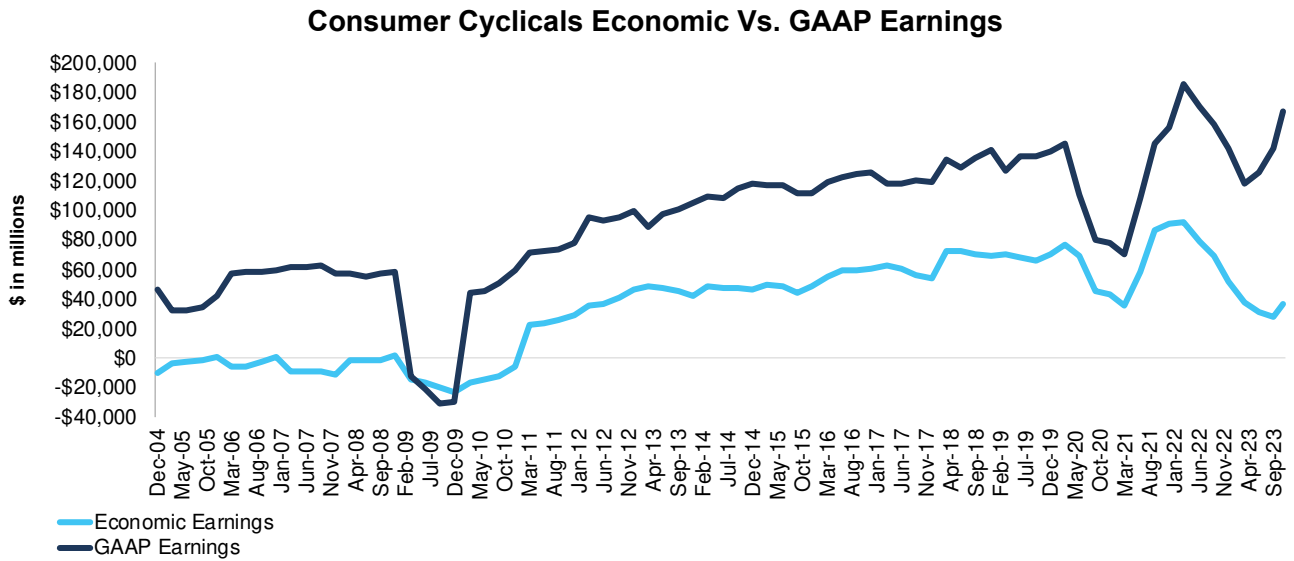

## ***Appendix: Calculation Methodology***

---

We derive the economic earnings and GAAP Earnings metrics above by summing the Trailing Twelve Month individual S&P 500 constituent values for economic earnings and GAAP Earnings in each sector for each measurement period. We call this approach the “Aggregate” methodology.

The Aggregate methodology provides a straightforward look at the entire sector, regardless of market cap or index weighting and matches how S&P Global (SPGI) calculates metrics for the S&P 500.
